The case has been presented before the Tribunal. Applicant/claimants with their Counsel appeared virtually on previous date. Through **Application 3B** applicants have prayed for release of compensation amount.

Heard and perused the record which transpires that on the basis of merit award of ₹10,67,920 with 7.5% simple annual interest from date of institution of petition was passed by the **MACT Jhansl** in **MACP No. 22 of 2018 on date 22.01.2021** in favour of Claimants. Claimant No. 1 to 5 have to share 30, 25, 25, 5 & 15%. 75% of share amount of each Claimant No. 1, 4 & 5 have to be Fix Deposited for 3 years and 100% of share amount of Claimant No. 2 & 3 have to be Fixed Deposited for 10 years.

According to office report Insurance Co. has deposited ₹12,86,345 through UTR No. AXISP00178810197 which are available in Tribunal's Syndicate Bank Account.

In support of release application 3B, the affidavit 4C2 is available on the record. As per affidavit no stay is in operation. Bank details and Aadhar Cards of Claimants has been placed on record.
