Permanand Gautam and Ors. vs. Jagdish Verma & Ors. 10.07.2021

The case presented before the Tribunal in Lok Adalat. Applicants with their Counsel appeared virtually. Through **Application 3B** applicants have prayed for release of award amount.

Heard and perused the record which transpires that on the basis of compromise award of ₹6,50,000 was passed by the MACT Jhansi in MACP No. 277 of 2017 on date 04.03.2021 in favour of the applicants/claimants Permanand Gautam, Smt Ram Sakhi and Km. Vandana Gautam with share 35, 35 & 30 percent respectively of which 75 percent each have to be invested in annuity for 3 years. Cholamandalam General Insurance Co. was also ordered to deposit the award amount in Tribunal's Punjab National Bank account.

As per office report Insurance Company have deposited ₹6,50,000 in Tribunal's Canara Bank Account electronically through UTR No. 70211436522955 on date 11.03.2021. Cholamandalam General Insurance Co. have deposited the award amount in Canara Bank instead of Punjab National Bank despite specific directions. It is notewothy that Canara Bank does not have annuity facility. The Tribunal take exception to the act of flouting by Cholamandalam General Insurance Co. and is warned for non-compliance of Tribunals order in letter and spirit.

In support of release application 3B, the affidavit 4C2 is available on the record. Bank details and Aadhar Cards of applicants are placed on record. Claimants further prayed that they are in dire need of money for marriage of Km. Vandana, hence 50% of their shares be released in their bank accounts.

Considering all the facts and circumstances, I am of the view that applicants are entitled to get 50% of their shares in their bank accounts directly and 50% in annuity accounts. Hence-
