

Motor Accident Claim Tribunal Jhansi

The case presented before the Tribunal. Applicants with their counsel & Counsel of National Insurance Co. Ltd. appeared virtually on previous date. Through **Application 3B** applicants have prayed for release of amount.

Heard and perused the record which transpires that **₹3,01,734** with **7.5%** simple interest were awarded to the claimants in **MACP No. 89 of 2017** on date **22.06.2020** by the **MACT Jhansi**. According to Award Smt. Rekha Kaushik has to get whole amount electronically in her account.

National Insurance Company preferred appeal against award in which (FAFO DEFECTIVE No.- 578 OF 2020) following order is passed by the Hon'ble High Court Allahabad-

On appellant depositing the entire awarded amount before the Tribunal, the execution of the order Impugned shall remain stayed. Out of the entire deposited amount, 50% shall be allowed to be withdrawn by claimants and 50% shall be invested in a Fixed Deposit Account-carrying maximum interest for minimum period of three years and the interest on it be paid to claimants. Order Date :- 24.11.2020
