**RULES FOR REGISTRATION**

Must be a member of the Oregon Appaloosa Breeders Association to register.

All appaloosa horses foaled in Oregon must be registered with the Oregon-Bred Appaloosa Breeders Assoc. before they will be allowed to show/run in any Oregon-Bred class/race. In order for a breeder to legally claim the 10% breeders bonus for a winning Oregon-Bred within this State, such horse(s) shall, previous to being entered in any class/race in the State have ben registered and certified as an Oregon-Bred Appaloosa Horse with the Oregon Appaloosa Breeders Assoc. The breeders or his agent is eligible to file application.
