**<u>Responsibilities:</u>** The range of duties that is expected of the Junior Counselor is illustrated by the following specifications. The Junior Counselor will:

- Assist with camper safety and well-being during the implementation of the program.
- Assist in the core academic curricula.
- Assist teachers and senior counselors in the planning and implementation of recreational activities.
- Assist in the organization and education of activities and projects.
- Assist in the organization of field trips.
- Work closely with the children during recreational activities.
- Participate in weekly planning sessions and meetings.
- Supervise camper leisure time activities.
- Maintain a high degree of safety on camp premises and work sites.
- Assist nutritionist during the preparation and setup of daily meals.
- Assure that the facility is properly maintained at the closing of each day before daily departure.
- Perform all other duties as required or assigned

**Qualifications:** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill and/or ability required. Reasonable accommodation may be made to enable individuals with disabilities to perform the essential functions.

**Education and/or Experience:** High School student. Experience working with youth programs is a plus. Must possess skills and be knowledgeable of basic computer

platforms (Microsoft Products, Internet, email); Proof of State and Federal background clearance; strong collaboration, coordination, problem-solving, and organizational skills; and the ability to work effectively with staff, students, parents and community members.

Language Skills: Excellent communication skills (verbal, non-verbal and written)

**<u>Physical Demands</u>**: While performing the duties of this job, the employee must have the ability to:

- Lift up to 40 lbs.
- Work with children on floor
- Work outdoors in any variety of weather patterns
- Repetitive bending, stretching, and stooping
- Climb up and down stairs
- Have mobility to ensure the safety of children
