Responsibilities: The range of duties that is expected of a Senior Counselor is illustrated by the following specifications. The Senior Counselor will:

- Plan, organize and lead groups of assigned campers in a variety of recreational experiences to teach skills, encourage creativity and enjoyment and provide constructive opportunities for developing teamwork and other positive life skills.
- Supervise Counselors and Junior Counselors in the absence of the Program and Assistant Directors.
- Oversee daily operation of program components and provides support for other program staff.
- Advise and assist Counselors and Junior Counselors in all of their duties.
- Maintain attendance rosters for reporting documentation.
- Instruct campers in the proper handling of recreational equipment.
- Assist in the organization and planning of weekly field trips.
- Administer vehicle safety during field trips and other outings.
- Develop and implement special programs as necessary.
- Participate in regular planning and evaluation meetings.
- Assist in public relations and serves as camp liaison between programs and parents/sponsors.
- Maintain a high degree of safety on camp premises.
- Assist director in inventory of supplies and materials necessary for program implementation.
- Supervise camper leisure time activities.
- Responsible for the well-being and health of the campers.
- Assist Teachers in instructing the campers in the core academic curricula.
- Be responsible for the planning and implementation of recreational activities.
- Assume authority in the administration of the camp when the Program Director, Assistant Program Director and/or Teacher are not present.

- Implement daily/weekly educational activities.
- Serve as immediate supervisor of Counselors and Junior Counselors
- Instruct campers in the proper handling of recreational equipment.
- Assist in the organization of field trips.
- Be responsible for administering vehicle safety during field trips and outings.
- Participate in weekly planning sessions and meetings.
- Supervise camper leisure time activities.
- Assist in public relations and serve as camp liaison between the program and parents/sponsors.
- Maintain a high degree of safety on and off camp premises.
- Assist teachers in inventory of supplies and materials necessary for program implementation.
- Assist teachers in development of daily program activities and projects to be carried out throughout the day.
- Perform other duties as required or assigned

Qualifications: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill and/or ability required. Reasonable accommodation may be made to enable individuals with disabilities to perform the essential functions.

Education and/or Experience: Associate or Bachelors degree in education preferred. Must have experience working with youth development programs. Background in education, physical education or outdoor leadership experience preferred. Must possess skills and be knowledgeable of basic computer platforms (Microsoft Products, Internet, email); Proof of State and Federal background clearance; CPR certified; First Aid certified; strong collaboration, coordination, problem-solving, and organizational skills; and the ability to work effectively with staff, students, parents and community members.

Language Skills: Excellent communication skills (verbal, non-verbal and written)

Physical Demands: While performing the duties of this job, the employee must have the ability to:

- Lift up to 40 lbs.
- Work with children on floor
- Work outdoors in any variety of weather patterns
- Repetitive bending, stretching, and stooping
- Climb up and down stairs
- Have mobility to ensure the safety of children

Work Environment: The work environment characteristics described here are representative of those an employee encounter while performing the essential function of this job. Reasonable accommodation may be made to enable individuals with disabilities to perform the essential functions.
