CCR POA ROAD REPORT

ROAD REPORT: Shawn Miller, Road Committee Chair/Member

- I. Following the last round of storms, a ride around was done on the roads in order to assess damage(s):
 - A. Although there are repairs to be made, all roads were navigable;
 - **B.** Many residents used their own equipment to repair some parts of the roads;
 - C. Chris Romiti communicated with Freeport-McMoRan ("Freeport") and was able to get Freeport to repair and blade most of the worst road areas at no-charge to CCR POA.
- II. The Road Committee is recommending that CCR POA award a contract for the following to Dixon Materials at a cost of \$25,215.00:
 - A. Blade all roads;
 - B. Installation of an additional 200 tons of material(s) to Black Peak;
 - C. Installation of 150 tons of material(s) to Copper Canyon Drive at the Big Johnny Wash.
 Note: Further evaluation of the roads will be conducted after completion of contracted work.
- III. Shawn Miller the Road Committee Chair is currently obtaining pricing on installation of culvert pipe along the bottom of Black Peak Road where the current drainage ditch is eroding the road and the adjacent lot.
- **IV.** Other areas which we would like considered for placement of additional material:
 - A. Approximately an additional 100 tons to Black Peak at \$4,425.00;
 - **B.** Approximately 150 tons on Copper Canyon Drive from Breezy Hill to Blue Jay at \$6,640.00;
 - C. Approximately 100 tons on the far south end of Copper Canyon Drive, where it has become too rocky to run Blading at \$4,425.00.

Note: Most of this can be covered by deferring the previously scheduled concrete work on Black Peak (\$11,000.00), which would increase the current approved expenditures by \$4,490.00.
