CALL FOR NOMINATIONS

This is a call for nominations for Board Directors. All property owners are being asked to consider if they or someone they know has time, desire and qualifications to serve the Association as a board member.

The volunteer election committee is proposing that the nomination and then the election of the new Board members be performed using a mail in (or email) ballot process. The ballots will be developed from the nominations received and ballots will contain the names of all the nominees that meet the legal CCR defined qualifications and sent out in a second mailing. The new board will serve from March 2026 through March 2027.

The Nomination Form is provided for PROPERTY OWNERS who wish to run for the Board of Directors. If you wish to nominate someone or wish to join the Board, fill out the enclosed Nomination Form and return it by **US mail or electronically sent no later than January 31, 2026**. This will ensure all members will have the opportunity to review the nominees on the Association website and time for the nominees to be added to the ballot for the **February 15, 2026** mailing to all members for voting.

All nominees should review our Bylaws and Covenants, Conditions and Restrictions (CCR's) to determine the obligation, duties, and powers of the Board. These documents are available for review on the Association website. There are also Arizona Revised Statutes that have been updated within the last two years that are applicable.
