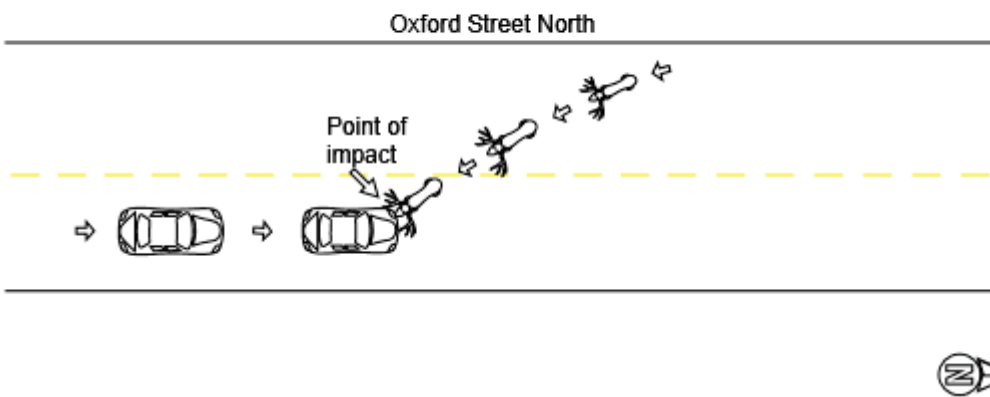
**Crash Diagram:**
