Treasury report from Eli Kuznetsov:

Treasury report was presented, discussed and accepted by majority vote.

Membership report from Roy LeBlanc:

1. The 3D targets are not holding up with the weather and other damage. Topic deferred until the spring.

House and Grounds report from Joe Frassica:

1. Kitchen progress
 - a. Structural issues were identified during demolition requiring modifications. These need to be completed before construction can proceed.
 - b. Budget discussion:
 - i. The board approved a \$10,000 allocation to cover various expenses as they are identified during construction. Fund will be controlled by Joe Frassica.
2. Air Filter has been replaced by Joe Mahoney
3. Motion to service the heater in the Skeet House. Charlie Walsh will take a look this week and report back.
4. Outdoor Grill need to be replaced. \$1,400 (Not to exceed) was approved by vote to replace and Lou Shriber will also provide a refurbished grill for our use.

Old Business:

 - a. General discussion regarding our position on the program and do we want to move forward with their program at our club.
 - b. Joe will draft a paper with the requirements that the group would have to adhere to before we will allow them to use or facility.

New Business:

1. Discussion regarding range safety and use of proper safety equipment. There have been situations where someone, during orientation, did not bring the appropriate safety equipment and they borrowed someone else's at the range portion of the orientation. Going forward, if the attendees do not bring the proper safety equipment they will not be allowed to complete orientation and will have to reschedule. **Action:** Joe will look at wording on website to reflect this.
2. Indoor range issues – The indoor range is getting more use this time of year with the weather. This is resulting in more damage to the range and lots of stray shots. Guidelines email will be sent out after first of the year to increase awareness of activities causing damage. Motion passed for a budget of \$9,000 for new baffle close to shooting stations. General note: There will be an upgrade to the indoor range in 2026. More info to follow.
3. Andrew Piechowski volunteered to replace Joe Mahoney as general board member.
4. Motion was passed to provide refreshments and the annual meeting.
5. Roy LeBlanc will prepare a ballot for the elections at the annual meeting.
