## Massapoag Sportsmen's Club

BOD Minutes 16 - September - 2025

#### **Minutes:**

The BOD of the Massapoag Sportsmen's Club (MSC) convened on Tuesday, September 16th, 2025. The meeting began at 7:00 pm in the MSC clubhouse. Those in attendance are listed below.

- 1. Treasury report from Eli Kuznetsov.
  - a. Year-to-date revenues equal \$125K (which includes \$6K of interest income). Expenses equal \$112K, and Net Profit equals \$13K. COH equals \$376K.
    - Revenues are primarily membership payments and skeet/trap revenue. Expenses include a large purchase of clay targets.
    - ii. It was noted the Real Estate tax exemption for recreational land needs to be filed soon (October).
- 2. Membership report from Roy LeBlanc.
  - a. As of September 16, 2025, total membership is 550 (all categories). Membership breakdown is: 462 General, 5 Life, 72 Senior, 7 Senior & Life combined, and 4 Honorary.
  - b. Approximately 476 members renewed their membership and there are 70 new members, and 4 former members who have re-joined.
- 3. Shotgun sports report from Joe Frassica.
  - a. The most recent registered shoot was canceled due to low sign-up. It is believed that the date being too close to Labor Day may have been partly responsible. The event will be scheduled later in the year next year, possibly October.
    - i. It was noted that participation in registered events is down in the state of Massachusetts.

- b. The interclub match with Sharon Fish & Game is approaching. The first event will be held at MSC on the 20<sup>th</sup> of this month (September). The second event will be a week later at SF&G.
- c. The ventriloquist bullhorns for the trap field have been fixed and are up and running.
- 4. Pistol report from Roy LeBlanc.
  - a. The Pistol group had 11 regular shooters and a few guests for the most recent shoot.
  - b. Pistol shoots consist of the traditional slow-fire and rapid-fire events, and a .22 rifle shoot.
  - c. The range continues to be clean and ready for all pistol shooters. Any members interested in participating in the monthly pistol shoot should contact Mr. LeBlanc.
- 5. Archery report from Micky Cochrane.
  - a. Mr. Cochrane reported that new covers have been installed on the bullseye targets. They are made from a tougher material and are expected to last longer.
  - b. Two of the 3D deer targets have broken legs and need replacing. Mr. Cochrane requested the BOD to replace the targets at a cost of approximately \$500.
  - c. In addition, many of the hay bales in the back stop are rotting/settling and need replacing. Mr. Cochrane estimated he would need about 15 bales at a cost of about \$190 (which includes a \$40 delivery charge). The BOD approved this expenditure.
- 6. House and Grounds report from Joe Frassica.
  - a. The indoor range baffles have been built and should be installed next week.
  - b. The blades on the ventilation fans will be cleaned soon, now that we are experiencing cooler weather.
  - c. Update on the HVAC. Looking at a sealed combustion unit and we are currently waiting on a proposal. The original

cost was \$8,200. Looking for additional installation, electric and/or plumbing with an auto shut off timer. This will mean there is no open flame/combustion in the building. Safer and more efficient. Expect an update in approximately 1 week.

- d. The gas line in the kitchen has been disconnected.
- e. There was some discussion concerning winterizing the kitchen so that pipes don't freeze. We need to develop a plan for what we want the kitchen/kitchenette to be in terms of usage/capacity etc.
- 7. New Business.
  - a. Roy LeBlanc requested \$400 for printing and postage and this was approved.

There being no other business the meeting was adjourned at 8:36 pm.
