# 2025 Session Overview



Thank you to all who continue to support the work of the Women's Lobby of Colorado. We have been fighting for gender equity at the Capitol for over 30 years. We could not do this work without our members as we are all stronger together. We also wish to thank the legislators who sponsored and fought hard for bills that improve Coloradans' lives.

Our organizational members got several important bills passed this year, including bills that help shield sexual assault victims from having irrelevant evidence be introduced in civil suits (HB25-1138), protect domestic violence and stalking victims who are tenants (HB25-1168), and expand wage theft protections (HB25-1001).

This year's session was marked by highs and lows. Legislators shored up protections for women, LGBTQ+ people, and immigrants against detrimental actions by the federal government. Anti-worker and anti-environment bills were introduced, some of which passed. Governor Polis has vetoed a bill that would have brought Colorado in line with every other state by doing away with a second required vote to unionize, and a bill to protect Uber/Lyft riders from sexual assault.

We are proud of our work and grateful for your support. We will continue fighting for women and families. We would also like to express our gratitude to our amazing lobbyist, Emma Bliesener. She keeps us informed and focused throughout the chaos of session.

# *Our Priority Bill*

## *HB25-1208*



---

For the first time in our history, we chose a bill we opposed as our priority bill, HB25-1208, “Local Governments Tip Offsets for Tipped Employees.” The fact that this harmful bill had Democratic sponsors was especially shocking. Tipped employees are paid less than non-tipped employees in most businesses. As introduced, this bill mandated a huge wage cut for the lowest-paid employees—tipped employees—in local jurisdictions that have a higher than state minimum wage. Tipped employees are largely women, and are the only category of employee who is required to subsidize their own wages.

The Women’s Lobby was proud to join a broad coalition in opposing this terrible bill. Hundreds of people testified against it, including us. After the hearing in the House Finance Committee, the bill’s House sponsors did a strike below and changed it from a mandated immediate 25% wage cut to permitting local governments to choose to increase the amount of tips workers must give towards their wages. We remained opposed because the amended bill does not allow local governments to eliminate lower wages for tipped employees.

We thank the legislators who spoke eloquently against this bill, particularly Representatives Garcia and Zokaie in the House Finance Committee, and Speaker Duran, who was instrumental in getting the bill amended to be less harmful.

Governor Polis signed HB25-1208. You can see how your legislator voted on the following two pages. A no vote supported workers.

# *What our lawmakers were doing in 2025*



## **SB25-003 Semiautomatic Firearms & Rapid-Fire Devices**

**Sponsors: Sen. T. Sullivan, Sen. J. Gonzales, Rep. A. Boesenecker, Rep. M. Froelich**

So far in 2025, there have been at least 118 mass shootings. Shooters use semiautomatic weapons in nearly all mass shootings. Our priority bill last year, HB24-1292, would have banned the sale and transfer of certain semiautomatic weapons and rapid fire devices, but after passing the House, it was killed in the Senate. We are so glad to see legislators this year managed to pass this bill against stiff opposition, and we thank the sponsors for their amazing work. SB25-003 bans the sale, manufacture, purchase, distribution, and transfer of certain semiautomatic firearms with exceptions allowed to certain categories of people, including those who complete training. Governor Polis signed this bill into law on April 10, 2025.

## **SB25-005 Worker Protection Collective Bargaining**

**Sponsors: Sen. R. Rodriguez, Sen. J. Danielson, Rep. J. Mabrey, Rep. J. Bacon**

Colorado is the only state that requires a second election for unions to negotiate a union security agreement clause in the collective bargaining process. This bill eliminated that requirement, thus lessening the chances for employers to engage in union-busting activities after the first election. In a shocking anti-labor move for a Democrat, Governor Polis vetoed the bill. In continuing his preference for business over workers, he had threatened all during the session to veto the bill “unless business agreed to it.” No bill that helps workers in any manner would ever pass the legislature if business agreeing to it was a requirement.

## **SB25-276 Protect Civil Rights Immigration Status**

**Sponsors: Sen. J. Gonzales, Sen. M. Weissman, Rep. E. Velasco, Rep. L. Garcia**

This bill expands existing law protecting immigrants through prohibitions that limit the disclosure, collection, and access to a person’s personal identifying information from just state agencies to political subdivisions, expands the classes of crimes criminal defendants may petition to vacate guilty pleas to based on not being fully informed of the plea’s effect on immigration status, and expands locations that must prohibit entry to ICE except in certain circumstances, among other provisions. Given ICE’s illegal activities since January 20th, this bill is needed. Governor Polis signed this bill on May 23, 2025.

## **Protecting Reproductive Rights Package**

- **SB25-183 Coverage for Pregnancy-Related Services**

**Sponsors: Sen. R. Rodriguez, Sen. Daugherty, Rep. L. Garcia, Rep. J. McCluskie**

Senate Bill 129 shields Coloradans who have engaged in a legally protected health care activity, including abortion and gender-affirming care, from out-of-state civil or criminal actions. SB25-130 requires hospital emergency departments to stabilize patients they are not willing to treat before transferring them, and prohibits such facilities from denying care or discriminating against patients in the provision of emergency medical services. Thank you to our organizational member, Cobalt, for their inspiring advocacy on these bills. Senate Bill 183 codifies voter-approved Amendment 79, which adds a constitutional right to abortion, repeals the constitutional ban on using public funds for abortion, and requires private insurance to cover abortions. Governor Polis signed all three bills.

## **SB25-001 Voting Rights Act**

**Sponsors: Sen. J. Gonzales, Rep. J Bacon, Rep. Junie Joseph**

Colorado has an election system that is a model for the country. This bill is part of shoring up voting protections in Colorado given the dangers of the current federal administration (see, e.g., H.R. 22, the SAVE Act, which will disenfranchise millions). It enshrines the federal Voting Rights Act into Colorado law, and contains additional protections and heightened access for various groups. Governor Polis signed this bill into law on May 12, 2025.

## **HB25-1090 Protections Against Deceptive Pricing Practices**

**Sponsors: Rep. E. Sirota, Rep. N. Ricks, Sen. M. Weissman, Sen. L. Cutter**

This bill benefits consumers by requiring transparency in pricing in several ways, including showing total prices including fees at the beginning, rather than hidden at the end of a transaction. It protects tenants by prohibiting landlords from charging outrageous fees for things that are the landlord's responsibility, like common area maintenance, and prohibits fees on fees. Congratulations to member organization Colorado Coalition for the Homeless for getting this bill passed. Governor Polis signed this bill into law April 21, 2025.

## **HB25-1040 Adding Nuclear Energy as “Clean” Energy Resource**

**Sponsors: Rep. A. Valdez, Rep. T. Winter, Sen. D. Roberts, Sen. L. Liston**

We opposed this bill. It adds nuclear energy to the list of clean energy that is eligible for public financing and allows a utility to include nuclear energy towards its clean energy goals. There is nothing clean or safe about nuclear energy. From uranium's extraction, which causes cancer in miners and millers, to increased risk of cancer to those living in proximity to plants, to the fact that there is no safe way to store our existing radioactive waste, nuclear energy is bad for people and the environment. It is the most expensive form of energy. Bills like this are being pushed across the country by technology companies to get tax money to build nuke plants to support their data centers. Ratepayers end up paying for these. We also opposed SB25-280, Data Center Development & Grid Modernization Act. We did not score this bill because it was killed, but we expect that tech companies will be back next year seeking our tax dollars to build these power-sucking, water-wasting centers. Governor Polis signed HB25-1040 March 31, 2025.

## **HB-1239 Colorado Anti-Discrimination Act**

**Sponsors: Rep. Y. Zokaie, Rep. A. Boesenecker, Sen. L. Daugherty, Sen. M. Weissman**

For too long, people with disabilities have been treated as second class in the Colorado Antidiscrimination Act (CADA). Despite federal laws that have been in effect for decades, public accommodations are still not accessible to people with disabilities. Until this bill, those who were victims of discrimination by public accommodations were unable to get noneconomic damages under CADA. We thank the sponsors for shepherding this bill to passage, particularly progressive champion and freshman Representative Zokaie, who put an immense amount of work into this bill. Governor Polis signed this bill May 22, 2025.

## **HB25-1312 Legal Protections for Transgender Individuals**

**Sponsors: Rep. L. Garcia, Rep. R. Stewart, Sen. F. Winter, Sen. C. Kolker**

Titled the “Kelly Loving Act,” this was one of the most contentious bills of the session. The bill was amended to remove the most controversial sections affecting parenting. The bill provides that marriage and civil union licenses must be reissued in the new name at the request of a person providing proof of a documented name change, with no indication the license has been altered. It also adds a definition of “chosen name” to CADA and requires schools to allow students to choose from any option provided in a dress code policy. Governor Polis signed this bill into law on May 16, 2025.
