1. GO TO THE PGA JUNIOR LEAGUE GOLF WEBSITE AT PGAJRLEAGUE.COM AND REGISTER YOUR PLAYER FOR THE INDIAN CREEK TEAM. YOU WILL HAVE TO PAY AN ADMINISTRATIVE FEE OF \$75.00 UPON REGISTRATION. THIS COVERS ANY SUPPLIES SUCH AS TEAM JERSEYS, BALLS, BAG TAG, HAT.
 2. GO TO THE INDIAN CREEK PRO SHOP AND FILL OUT THE INDIAN CREEK TEAM REGISTRATION FORM AND PAY THE \$175.00 FEE WHICH COVERS YOUR GREEN FEES, WARM UP RANGE BALLS, TEAM PRACTICE SESSIONS. THIS FEE IS DUE NO LATER THAN MAY 15.
 3. ONCE THE REGISTRATION PROCESS IS COMPLETED, I WILL CONTACT ALL PLAYERS FOR A PARENT/PLAYER MEETING TO GO OVER THE LEAGUE RULES, FORMAT, AND SCHEDULE. WE WILL HAVE TWO INTRASQUAD PRACTICE MATCHES SO EVERYONE UNDERSTANDS HOW THE COMPETITION WORKS. **REGISTRATION STARTS ON FEBRUARY 1** AND CONTINUES UP UNTIL THE LEAGUE STARTS, WHICH IS **MAY 31**. PLAYERS CAN BE ADDED AFTER THE REGISTRATION DEADLINE, BUT WILL FIRST HAVE TO CONTACT ME TO BEFORE YOU REGISTER ON THE PGA SITE.
4. MANDATORY WAIVER FOR PARENT TO SIGN.
