#### Check-in/Check-out:

## MAXIMUM LENGTH OF STAY IS 5 MONTHS AND 29 DAYS IN A CALENDAR YEAR

- Check-in time is 1:00 pm. Upon arrival all guests must register at the office before being escorted to their site.
- If arriving after closing you will need to contact our office for our late arrival procedures. At that time we will make arrangements (via phone) to complete the necessary paperwork and set up your account for Vero Beach Kamp INC. This **must** be complete before you can be parked.
- Checkout time is 12:00 noon; please check out or re-register before noon. Campground fees are payable by check-out time of due-date. All fees are payable in advance. Late check-outs can be requested (subject to availability) There will be a **\$50.00 per hour** charge for all unapproved late departures.

#### **RV restrictions:**

- All RVs must be currently registered and maintained in good condition.
- All RVs are subject to an external inspection before entering the park.
- RVs 10 years or older must be approved by Vero Beach Kamp <u>prior</u> to making a reservation.

# **Deposits:**

- All reservations that are 3 nights or less require payment in full at the time of reservation.
- Reservations 4- 29 nights require a deposit of <u>half</u> of the total reservation fee with remaining balance due at check-in.
- Reservations 1 month to our maximum length of stay of 5 months and 29 days require a security deposit of \$300 Monthly reservations who do not fulfill their **original** commitment with Vero Beach Kamp will lose their security deposit
- Cabin and cottage rentals require a security deposit of \$50 that will be returned to you at check out in your original form of payment should the rental unit(s) be found in the same condition it was rented in and no evidence of smoking or other damage inside the rental unit.

Any damage to Vero Beach Kamp rental units, whether accidental or willful, is the responsibility of the registered guest for each particular rental unit. Any costs associated with repairs and/or replacement will be charged to the credit card of the registered guest. In extreme cases, criminal charges will be pursued.

## Payments with Vero Beach Kamp:

- Payments for daily stays (1-29 days) are due at check-in in full.
- Payments for monthly stays: first month due at check-in all other months rent and electricity are due monthly based on the date you check in (Ex. Check in April 12th, due every month on the 12th)

Monthly payments not made on the kampers specific due date will be subject to a late fee

# Holidays:

 All holiday weekends require a 3-night minimum stay with payment in full at the time the reservation is made

## **Cancelation Policy:**

• For monthly reservations, i.e. 30 or more days, Vero Beach Kamp requires a <u>written notice</u> of cancellation of stay within 3 months (90 days) prior to the start of your **original** reservation date. Any reservations made inside this 3-month (90 day) grace period will automatically default to a <u>non-refundable</u> status and any cancellation of a reservation will result in a loss of security deposit. Monthly reservations who do not fulfill their **original** commitment with Vero Beach Kamp will lose their security deposit.

A refund of less 10% of the security deposit and a processing fee will be refunded to you via check in 4-6 weeks.

- For daily reservations, i.e. less than 30 days, Vero Beach Kamp requires a 1 day 1(24 hours) notice of cancellation from the original reservation date. *A refund of deposit, less 10% of total stay and a processing fee will be refunded via check in 4-6 weeks.*
- All cancellations made outside of the proper time frame will forfeit the entire deposit.

# No-show Policy:

• Any guest that has not arrived within <u>24 hours</u> of the first day of their reservation and has not contacted the park staff will be considered a canceled reservation and will forfeit their entire deposit.

## **Refund Policy:**

- There are NO refunds after check-in.
- Camping is an outdoor experience therefore refunds will not be given due to weather conditions, voluntary departure, acts of nature or removal from park.
- Any refund of pre-check in cancellations will be processed in 4-6 weeks and be returned to you via check in the mail.

#### RV sites, Tents & Cabin/Cottage:

- No loud music, profane language or disorderly conduct allowed. **Quiet hours 10:00 pm-8:00 am** are strictly enforced
- Children under 16 years of age may not leave their campsite after 10:00 pm unless going to/from the bathhouse or accompanied by an adult.
- NO SMOKING OR PETS ALLOWED IN CABIN OR COTTAGE
- The park provides 1 picnic table per site. No bricks or stepping stones may be added to the site.
- Any carpet placed on the grass must be breathable carpet
- NO CLOTHESLINES OF ANY KIND ALLOWED ON PARK <u>PROPERTY</u>
- FREE STANDING PROPANE TANKS ARE NOT ALLOWED.
- Joining of sites is not permitted
  - Keep campsites free of debris and unsightly items. No items stored under trailers or motor
    - homes.
    - Any outside refrigerators must have locks on them.
- Converted buses are not permitted
- **Ground fires are only permitted in a fire ring** Fire rings are available upon request on a first come, first served basis. You are welcome to bring your own fire ring
- Tents are **only** permitted in designated tenting areas. Tents are not allowed on RV sites
- For sale signs MAY NOT be displayed at sites and SITES MAY NOT BE SUBLEASED.
- Trees are our most valuable possession. Do NOT cut or deface any trees or drive nails, screws or any metal objects into them.
- NO DOG CHAINS OR HAMMOCKS ON TREES
   The discharge of firearms, fireworks or other pyrotechnics is STRICTLY PROHIBITED

#### Visitors:

•

- Visitors are required to register in the office when entering the park. (Including but not limited to; food delivery, contractors and personal visitors)
- Any contractor performing work within the campground must have a certificate of insurance on file in the main office, listing the park as additionally insured
- The maximum number of guests on any site is not to exceed <u>6</u>
- Guests are responsible for their visitors and are liable for any damages that they cause while on Vero Beach Kamp Inc property.
- Overnight visitors must register for their nights stay in advance.
  - All other guests must leave the park by 10:00 pm. Any visitor that does not register will be removed.

#### **Smoking and alcohol:**

- Smoking is prohibited in all common areas in the park.
- Alcohol is permitted to be consumed in the park in a responsible manner.

## Accidents/Incidents:

- All accidents or incidents <u>must</u> be reported to the office.
- Any damage to Vero Beach Kamp rental units, whether accidental or willful, is the responsibility of the registered guest for each particular rental unit. Any costs associated with repairs and/or replacement will be charged to the credit card of the registered guest. In extreme cases, criminal charges will be pursued.

## <u>Trash:</u>

- Put garbage in a bag and place it at the edge of the road by 11:00 am. Please do <u>NOT</u> put trash bags out overnight due to animal activity.
- Recycle bins are located near the trash receptacles; please ensure that **only** recyclable items are placed in the appropriate bin

#### **Driving Vehicles:**

- MAXIMUM speed limit is 5 MPH
- -Strictly enforced
- Mini-bikes and motorcycles are not to be ridden around the campground. *They may only be ridden to your site and back out.*
- All vehicles must have a valid license plate, current registration and **must** obtain a parking pass from the office at check-in.
- Parking is NOT allowed on the roadways, grass or any vacant site.
- Please only use designated roadways.
- The maximum number of vehicles permitted on a site is three (3). This consists of a motor home, travel trailer, 5<sup>th</sup> wheel, car, truck, utility trailer and boat. All other vehicles must use designated storage areas and be paid for.
- Personal golf carts may be driven by licensed drivers ONLY and must obey speed limits at all times. If operated after dark, they must be equipped with working lights on front and rear, ATV's and off-road vehicles are prohibited. **Parking rules will be enforced at all times and may result in towing at the expense of the guest or vehicle owner.**

#### ANIMAL GUESTS:

- Vero Beach Kamp Inc reserves the right to reject the admittance of any pet.
- NO AGGRESSIVE DOGS ALLOWED
  Pet and service animal vaccination records must be
- available upon requestPets are not allowed in buildings and must be on a leash
- AT ALL TIMES. No pets in restrooms, showers or pool areas.
- Pets and service animals must wear a collar with the identification of the owner and a phone number
- Please control barking dogs. Pets or service animals must not bother other guests
- Do NOT leave pets or service animals unattended at any time
- Camper is responsible for cleaning up after his/her pet or service animal

Animal sanitation stations are provided around the park for your convenience

#### Pool and other common areas:

- Pool hours are 10:00 am- Dusk
- Parents are responsible for the conduct and safety of their children. Children *under 10 years of age must be accompanied by parents or guardians at the pool and playground.*
- No glass, food or drink permitted in the pool area.

# <u>Mail/Deliveries:</u>

- Mail will be received and held in the office. Please check for mail after 3:00 pm *Any delivery drivers (food, packages etc) MUST stop at the* 
  - office and obtain a visitor pass.

#### Wildlife:

- Clean fish where you catch them or use the fish cleaning station in front of the Maintenance Building. Oyster shells, clams and fish remains must be placed in a garbage container and then taken to the dumpster.
   PLEASE MAKE SURE TO CLEAN THE AREA when you are finished.
- For your safety, please use caution around the park roadways and tree lines. Snakes, alligators and spiders can be concealed in vegetation or other dense cover. Snakes will warm themselves on the blacktop or concrete and other animals are active at night, please always carry a flashlight while walking in the dark.

# <u>Use of utilities:</u> We request your cooperation in the conservation of energy

- Please turn of your air conditioner when leaving your trailer
- NO unapproved WASHING of vehicles. If you would like to wash your RV or vehicle during your stay please contact the main office to purchase the required \$10.00 permit
- Inflatable or plastic pools are not allowed
- All monthly guests are responsible for the electricity they use. Each site is metered and charged for usage. *Electricity payments are due on your personal due date any late payments are subject to a late fee*
- Laundry services are available 23/7
- (closed 1 hour a day for cleaning)
- Do not leave laundry unattended in the laundry mat. Vero Beach Kamp is not responsible for lost or stolen items in the laundry facility.
- Baby wipes, sanitary products and other foreign objects ARE NOT TO BE FLUSHED IN TOILETS
- No draining of water on the grounds If any hose is found leaking, you will be charged a surcharge
- Sewer hoses must be undamaged and sewer connections must be tight fitting. Replacement sewer hoses can be purchased at the main office.
