RESOLUTION NO. 20-04

A RESOLUTION DECLARATION OF STATE OF EMERGENCY DUE TO COVID-19

The Board of Trustees of Union Township, Miami County, Ohio met in an emergency session on the 21 day of March, 2020 at the office of the Board of Trustees of Union Township, Miami County, Ohio at 9497 Markley Road, Laura, Ohio with the following members present:

Philip S. Mote
Dennis L. Albaugh

Mr. Albaugh moved with a second by Mr. Mote declaration of state of emergency due to COVID-19.

WHEREAS, Coronavirus Disease 2019 (COVID-19) is a respiratory disease that can result in serious illness or death, which is caused by the SARS-CoV-2 virus that is a new strain of coronavirus that had not been previously identified in humans; and

WHEREAS, Union Township, Ohio, has been affected by COVID-19, which can endanger the health, safety, and welfare of persons in Union Township, Miami County, Ohio; and

WHEREAS, on January 31, 2020, Health and Human Services Secretary Alex M. Azar II declared a public health emergency for the United States to aid the nation's healthcare community in responding to COVID-19; and

WHEREAS, Ohio Governor DeWine issued Executive Order #2020-013 on March 9, 2020, declaring a State of Emergency for the COVID-19 pandemic; and




WHEREAS, the State of Ohio announced its first case of community acquired COVID-19 on March 11, 2020; and

WHEREAS, the event may exceed all locally available public and private resources available to alleviate the effects of this emergency; and

WHEREAS, the Board of Trustees of Union Township, in conjunction with the guidance from Miami County, who consulted with Miami County Public Health and Miami County Emergency Management Agency, has determined that it is in the best interest of Union Township, Miami County, Ohio to take all necessary actions to prevent COVID-19 from spreading.

NOW, THEREFORE, BE IT RESOLVED that as authorized by Ohio Revised Code sections 5502.21 through 5502.51, the Board of Union Township, Miami County, Ohio, hereby DECLARES that a State of Emergency (as defined by R.C. 5502.21(F)) exists in Union Township, Miami County, Ohio related to COVID-19 and necessitating the Board to undertake all actions authorized by said Ohio Revised Code sections as well as other provisions of law, required to protect the health, safety and welfare of the residents of Union Township, Miami County, Ohio.


