35th ANNUAL TOURNAMENT RULES 2024

This Tournament Will Be In Accordance With Rules Of USBC

1. This will be a Certified Singles and Doubles handicap tournament, 100% of 210.
2. Only active members of the **FLORIDA 500 CLUB, INC.** who are currently members of USBC shall be eligible to bowl in this tournament. **THE FLORIDA 500 CLUB, INC. and USBC CARD MUST BE SHOWN AT CHECK IN.**
3. Entrants must enter both events. A bowler may enter the tournament twice with a different partner.
4. Entrants will bowl 3 games on a single pair of lanes per event.
5. If there is a tie for first place, the club may declare Co-Champions with first and second place money divided equally between the two and duplicate awards.
6. Prize fund for each event returned 100%. Prize ratio 1 in 5.
7. ENTERING AVERAGE as follows:
 - A. Highest 2024-2025 Bowl.com average as of 21 games or more.
 - B. Highest Bowl.com summer average of 21 games or more.
 - C. Current league verified average after 21 games as of October 1st, 2025
 - D. **10 PIN RULE-** If your October 1, 2025 average is 10 pins higher than your 2024-2025 Bowl.com average, you must report this change before the start of bowling in the tournament. If your average is found to be higher after the start of bowling in the tournament, the average will be adjusted.
 - E. All others will bowl scratch.

NOTE: All substitutes must abide by the entering average rules above.
8. **ANYONE USING A CURRENT SUMMER CERTIFIED LEAGUE AVERAGE MUST HAVE THE AVERAGE VERIFIED.**
We will accept an October 1st average with 21 games or more with proof of your highest certified league average with the latest league standing sheet.
9. **CHECK IN TIME WILL BE 1 HOUR BEFORE THE SCHEDULED STARTING TIME. IT IS NOT NECESSARY FOR DOUBLES PARTNERS TO CHECK IN TOGETHER.**
10. There is a '**NO SMOKING**' law in Florida. Tournament Bowlers are permitted to leave the bowling circle or center to smoke during tournament play. If not present when name highlighted, a zero will be given for that frame
11. Two practice balls on each lane or ten (10) minutes of practice depending on Center's Scoring System. No re-racks.
12. Any bowler who arrives after the scheduled shift has started will be permitted to bowl and score to count beginning with the frame being bowled. No score will be given for frames missed.
13. **SUBSTITUTES:**
 - A. Allow 1 hour notification time to the tournament office when a substitution is going to be needed.
 - B. Once a substitute comes in and start tournament play she will remain as a regular for the event.
 - C. Anyone who calls for a substitute must use the substitute unless she notifies the secretary 24 hours before the event.
14. USBC Rules 319-A (2) and 319-B, C, D & E shall not apply. Rules 319A (3) and (4) shall apply.
15. Any corrections on scoring errors must be made in writing within 24 hours to a tournament official.
16. As per Rule 329, any protests and appeals must be in writing stating the grounds for the protest or appeal. A protest involving eligibility or playing rules must be filed with tournament management and within 72 hours of the infraction, or prior to tournament prizes being paid, whichever occurs first.
17. Any entrants whose name appear hereon or their authorized replacement, hereby agree that the Florida 500 Club, Inc. its officers and directors shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought on by war, national emergency or emergencies or caused related thereto or resulting therefrom, fires, strikes, lockouts, labor difficulties or causes beyond the control of the Florida 500 Club Inc.
18. The host club will be scheduled last.
19. Any questions not covered by the rules will be decided by the Florida 500 Club Inc. Tournament Rules Committee as appointed by the board.
