ALL THREE PROGRAMS ARE STAFFED WITH VOLUNTEER MEDICAL STAFF AS WELL AS A NETWORK OF PEOPLE THAT HAVE BEEN AFFLICTED BY THE MUTATIONS THAT ARE WILLING TO PROVIDE SUPPORT TO OTHERS. THE PRECONCEPTION PROGRAM TESTS COUPLES THAT ARE OF REPRODUCTIVE AGE TO ENSURE THAT THEY DON'T CARRY GENE MUTATIONS THAT MAY BE PASSED ON TO THEIR OFFSPRING.
