Nature Coast Kayak Rental, LLC reserves the right to refuse use of the equipment by anyone.
- ons in Renter's party, whether adults or minors, utilizing any of the equipment, and for their acts which may cause damage or injury to property or persons. Renter is in good health, not under the influence of alcohol or drugs and is otherwise capable of safely operating the equipment provided.
- 3) Renter agrees to promptly return all equipment rented to the area rented from (if picked up or at place delivered) at the end of the rental period ("Return Time") in good condition. Renter agrees that Renter is liable for all "Additional Charges" as may be determined by Nature Coast Kayak Rental, LLC upon return of the equipment. Renter shall immediately notify Nature Coast Kayak Rental, LLC if equipment is damaged or stolen.
