Treasurer's report:

- Greg will reach out to the Whispering Pines and Country Shores campgrounds to see if they would be willing to contribute funds towards the Spiny Naiad remediation this summer since it affects them as well.
- Greg suggested that we may need to make some changes to the CPLA bylaws.
