### **Important Dates**

- **Applications Open:** November 1, 2025
  - **Applications Close:** November 15, 2025
  - **Voting:** December 16, 2025
  - **Winners Announced:** December 21, 2025, during the Town Hall
  - **New Roles Begin:** January 1, 2026
- 

### **General Guidelines**

- Even if you currently hold a position, **you must reapply** if you wish to continue serving.
- **You may only apply for one position.**
- Any unfilled positions after elections will reopen for additional applications.
- **No bribing or soliciting votes** — we lead with integrity and sisterhood.
- You **must have completed your ceremony** to qualify for a leadership position.



- **Chapter-level voting** will take place within your chapter. Applications will be sent to members for review and **anonymous voting via a secure link**.
  - **International-level positions** will be voted on sorority-wide.
  - You **cannot hold both an International and a Chapter seat**.
  - **International positions require time and active engagement** — only apply if you can commit.
  - Some chapters may not fill every position, and **that's perfectly okay**.
  - Remember: **You don't have to be an officer to be an active member**. Every Soror adds value — don't let anyone tell you otherwise!

### Chapter-Level Positions

- **Chapter President** – Leads the chapter, provides vision and direction, presides over meetings, and represents the chapter in sorority matters. Reports issues to the International Regional Director for area.
  - **Chapter Vice President** – Assists the President, manages chapter programs and committees, and fosters engagement and leadership growth.
  - **Chapter Treasurer** – Oversees chapter finances, budgeting, and reporting to ensure transparency and fiscal responsibility.
  - **Chapter Secretary** – Maintains meeting records, attendance, and correspondence, ensuring organized communication.
  - **Chapter Sergeant-at-Arms (Sgt at Arms)** – Maintains order during meetings, ensures compliance with procedures, and supports event logistics.
  - **Chapter Regional Support** – Serves as a liaison between the chapter and said regional to promote alignment and growth.

## International-Level Positions

- **International President** – Provides overall leadership, vision, and strategic direction for the sorority.
- **International Membership Director** – Oversees recruitment, retention, and engagement strategies across all chapters.
- **International Community Engagement Director** – Leads global service and philanthropy initiatives, promoting impact and involvement.
- **International Youth Director** – Develops youth-focused programs and mentorship opportunities.
- **International Secretary** – Maintains international records, documentation, and communication for organizational transparency.
- **International Chaplain** – Provides spiritual guidance and fosters sisterly connection and wellness. (Sisterly RHOlations Chair)
- **International Regional Director (3)** – Supports regional areas through leadership, compliance, and collaboration. Reports back to the International President.
- **International Committee Media Chair** – Manages public relations, social media, branding, and digital presence.
- **Assistant Dean of Pledges** – Supports the International Dean of Pledges in overseeing pledge education, mentoring, and development programs. (Interviewed and selected by DOP)
