Membership Overview by Intake Season

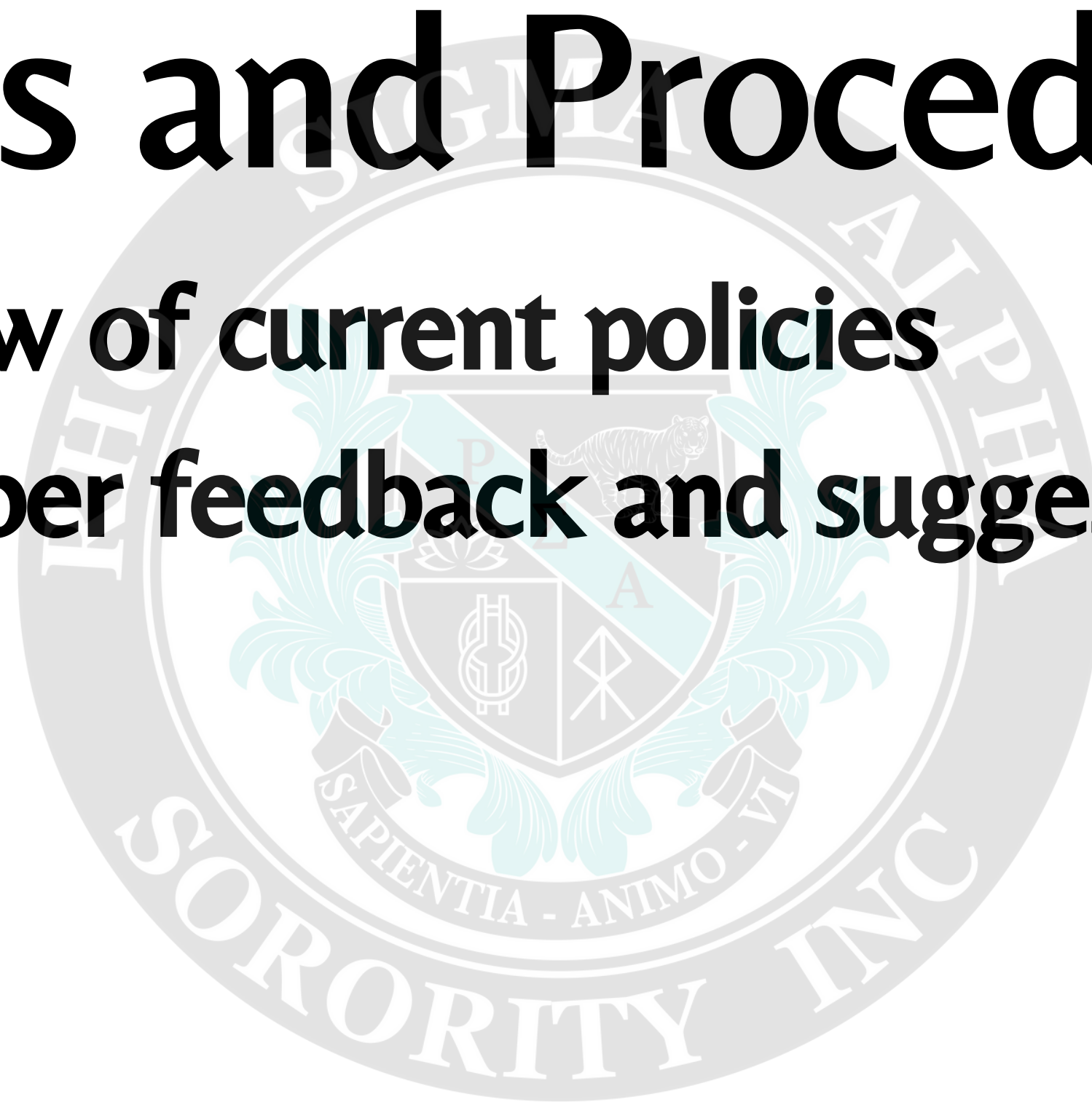

Rho Sigma Alpha Sorority Inc. Election Process

Nomination Period:

- To nominate yourself for any position, whether it be National Chairs, Chapter Chairs, or Committee Chairs, please complete the application form and submit it along with a video or essay detailing why you are applying for the position to Nominations@rhosigmaalpha.com.
- **Nomination period: November 1st to November 15th.**
- **Nominations announced to org Last Rho Tuesday of November**

Application Process:

- Applicants are required to submit a video or essay explaining their motivations and qualifications for the position they are applying for.
- The video or essay will be shared with all members to ensure transparency and informed voting.

Interview with Founders:

- Selected candidates will undergo an interview process with the founders to further assess their suitability for the positions.

Voting Process:

- Polls will be sent to each chapter for voting on Chapter positions.
- For National positions and Committee Chairs, voting will be conducted organization-wide.
- Voting will take place on December 10th each year

Announcement of Winners:

- The winners will be announced at a Town Hall Meeting in December- The term for elected positions will commence on January 1st , and last for one year.

Important Note:

- We emphasize that this is not a popularity contest. We urge all members to vote for candidates based on their qualifications, dedication, and commitment to serving the best interests of our chapters and organization.

Transition Plan:

- When founders vacate their national seats, the terms will extend to two years.

We encourage each member to actively participate in this election process. Your engagement is pivotal, and your vote will shape the future of Rho Sigma Alpha Sorority Inc.
