The owner is responsible for submitting it to Arrowhead Canine Reproduction if it's not provided during collection.

# Terms and Conditions

This is a legal agreement between you and Arrowhead Canine, LLC for services only, not for selling any products. You understand that Arrowhead Canine is not a veterinary clinic and does not offer veterinary services. Arrowhead Canine will collect, freeze, and store canine semen from your dog, and you authorize them to do this at your own risk. The semen will be available for you to use or ship following standard procedures, which will be provided afterward.

Payment is due at the time of service, unless you have an approved monthly payment plan: the initial fees cover collection, freezing, and the first year of storage. There are extra fees for storing semen, including preparation, tank rental, and actual shipping costs. All prices may change without notice.

You understand and agree that while Arrowhead Canine stores your canine semen, you maintain full ownership and control over it. You may request pickup or shipment of your semen at any time with reasonable notice and following Arrowhead Canine's procedures. You acknowledge that your account must be paid in full for the semen to be released, and Arrowhead Canine can place a lien on the semen if there are unpaid balances.

You agree to use our shipping tank or your own for pickup or shipment. Once you or an authorized agent takes possession of the semen or it is shipped per your instructions, you assume full responsibility for its safety and preservation. Arrowhead Canine is not liable for any damage to the semen once it is removed for shipment or use, and you agree to read all forms and instructions provided by Arrowhead Canine.

You understand and agree that it is your responsibility to obtain insurance for your shipment of semen. Any insurance that Arrowhead Canine obtains only covers their shipping container, not your canine semen. If there is any loss or damage to the semen due to events outside Arrowhead Canine's control—such as fire, earthquakes, flooding, weather, power outages, theft, vandalism, incorrect insemination, or shipping accidents—you agree not to hold Arrowhead Canine liable for the loss or costs related to freezing and storing the semen.

You understand and agree that if semen has multiple owners, each owner can individually authorize its shipment and use. All owners agree to indemnify and protect Arrowhead Canine and its staff from liability for owner disputes.

Late payments will incur a \$5.00 late fee each month. After 90 days of non-payment, your account will become inactive. You understand that after 90 days of inactivity, your semen is considered abandoned and will become the property of Arrowhead Canine, who may dispose of or use it as they choose, including for research, sale, or artificial insemination. Unpaid account balances may be sent to a collection agency. It is your responsibility to keep your account current with Arrowhead Canine. You agree to notify them immediately of any changes in your contact information or ownership of the semen.

You understand and agree that canine semen is a living organism that deteriorates over time, even when frozen. You acknowledge that Arrowhead Canine makes no promises or guarantees regarding the semen's viability, quality, or ability to result in conception. They are not liable for any outcomes from using the semen.

Arrowhead Canine provides services only and does not guarantee any specific results from the semen. They cannot ensure that frozen sperm will be viable when thawed for insemination. They are not responsible for differences in thawing rates or semen quality as assessed by the inseminator. You also agree that Arrowhead Canine is not responsible for services provided by individuals or entities not affiliated with them.

**By using Arrowhead Canine's services, you agree that their liability and that of their owners, employees, or agents will not exceed the total payment made under this Agreement. This serves as an explicit waiver of liability. This limitation applies to any claims, losses, expenses, injuries, or damages related to this Agreement, including issues like breach of contract, negligence, errors, or other reasons that are not willful misconduct. It covers lost profits, loss of use, replacement costs, special damages, and indirect or consequential damages, regardless of the cause.**

**If a dispute arises, it will be governed by Texas law, and all legal actions must be filed in the Circuit Court of San Jacinto County, Texas. You agree to this court's jurisdiction. The time limit for any claims related to this Agreement is one year; any claims filed after this period will not be accepted. This one-year limit applies to both you and Arrowhead Canine and overrides any other applicable time limits.**

**This Agreement replaces all previous agreements regarding the named stud dog and binds you, your heirs, successors, and Arrowhead Canine and its successors. It cannot be assigned to others. This document is the final agreement between you and Arrowhead Canine, and all prior negotiations are merged. The rest will still apply if any part of this Agreement is unenforceable. Waivers of any part must be in writing and signed by both parties. Changes to this Agreement can only be made in writing with both parties' consent.**

By signing below, you confirm that the information you provided is accurate. You authorize Arrowhead Canine to perform services at your own risk and agree to all terms and conditions in this Agreement. You permit Arrowhead Canine to charge your provided payment method for these services. Additional charges may occur later if extra services are needed, and Arrowhead Canine may or may not inform you of these charges beforehand. You acknowledge that ICSB has offered to estimate these costs and accept any fees charged without prior notification.

You are responsible for ensuring Arrowhead Canine is paid for all services rendered. You authorize Arrowhead Canine to perform additional services, either recommended or requested by you, with your verbal or written consent.
