Emissions Profile

- **Scope 1 & Scope 2 Emissions:** The company has no Scope 1 or Scope 2 emissions, as its activities do not involve direct fuel combustion or the consumption of purchased electricity, steam, heating, or cooling. Scope 2 emissions are not applicable to Jeev Lifeworks, as majority of the company operates remotely from home, with only a few employees working from a coworking space with utilities are covered by the rent. Consequently, these emissions are included under Scope 3, "Leased Assets," and are therefore not relevant to the company's GHG emissions profile. Therefore, Scope 1 and Scope 2 emissions are not relevant to Jeev Lifeworks' overall GHG emissions profile.
- **Scope 3 Emissions:** For the base year April 2023 - March 2024, our total emissions were 79.80 tCO₂e, all originating from Scope 3 categories, such as Purchased Goods and Services, Capital Goods, Business Travel, Employee Commuting, and Upstream Leased Assets.

Challenges in Emission Reduction

Given that Jeev Lifeworks does not have direct control over the majority of its Scope 3 emissions, implementing a traditional emission reduction plan is not feasible. However, this does not deter us from contributing to a sustainable future.

Our Commitment to Carbon Neutrality

Jeev Lifeworks is committed to achieving carbon neutrality starting 2025. We have adopted the carbon offsets strategy to ensure our continued commitment to sustainability. We will purchase carbon offsets equivalent to our emissions. This approach will allow us to neutralize our carbon footprint while supporting global sustainability goals.
