CANCELLATION & REFUND:

Notice of cancellation must be received in writing and shall take effect upon receipt of written notification. Deposits are non-refundable.

All cancellations or no-shows are subject to penalties and fees imposed by the supplier of the land and air arrangements. For air bookings purchased with the land arrangement provided by Globus, airfare and taxes are non-refundable after final payment is made. Instant Purchase airfare purchased from Globus is non-refundable and non-changeable 24 hours after purchase. For airfare purchased outside of the tour package offered, please note that different payment and cancellations policies may apply to airline tickets, depending on the carrier; and this information will be provided at the time of booking.

The Cancellation Fees shall be a percentage of the total price, calculated based on the number of days prior to commencement of service the cancellation notice takes effect:

- > 60 days = Non-refundable deposit
- 46 - 59 days = 15%
- 22 - 45 days = 25%
- 8 - 21 days = 35%
- 1 - 7 days = 55%
- < 1 day = 100%

Service refers to the package purchased whether land only or land and air. Total price refers to land package or land and air package purchased through Globus/Cosmos; it excludes Instant Purchase and airfare purchased outside of the tour package.

Revisions in flight bookings after the deposit is paid including but not limited to flight changes, flight cancellations and name changes are subject to rebooking fees, cancellation penalties and service fees, as applicable.

Once ticketed, cancellation/change penalties of at least \$300 per person up to 100% of the air price will apply. Cancellation penalties and fees will be quoted at the time of cancellation.

Cancellation fees also may apply to additional services requested/reserved prior to and during the tour. These may include optional excursions, extra night accommodations, and other independently supplied services.
