

# **Dispatcher Referral Partnership & Commission Agreement**

## *Between Truck Driver Nation and Independent Dispatcher*

### **Truck Driver Nation (TDN) – Referred Truck Dispatch Authorization**

This Agreement is made and entered into on Date: \_\_\_\_\_, by and between:

### **1. Purpose**

Truck Driver Nation refers trucks or owner-operators to the Dispatcher. The Dispatcher agrees to provide dispatching services to these clients.

---

### **2. Commission Fee**

- Dispatcher agrees to pay Truck Driver Nation 2% of the gross earnings generated by each truck or owner-operator referred by TDN.
  - This 2% is deducted from the Dispatcher's dispatching fee (e.g., if Dispatcher earns 10%, they keep 8%).
- 

### **3. Payment Method & Authorization**

- The Dispatcher agrees to complete and maintain an active **Credit/Debit Card Authorization Form** on file with Truck Driver Nation.
  - This card will be charged automatically for the 2% commission **after each invoice is submitted by the Dispatcher** and verified.
  - Failure to maintain an active payment method may result in suspension of referrals and/or legal collection proceedings.

### **4. Duration of Fee Obligation**

- The 2% fee obligation remains in effect **as long as the referred truck or owner-operator continues to receive dispatch services** from the Dispatcher.
  - If the operator ceases using the Dispatcher's services, the commission ends.

## 5. Reporting Requirements

- The Dispatcher agrees to submit a **monthly earnings report** for each referred truck or owner-operator, including load and revenue breakdowns.
  - Reports must be submitted by the **5th of each month**.
- 

## 6. Termination

- Either party may terminate this agreement with **30 days' written notice**.
  - All outstanding fees and obligations incurred prior to termination remain due and enforceable.
- 

## 7. Confidentiality

- The Dispatcher agrees not to share, disclose, or use any proprietary or business information received from TDN for any unrelated business purpose.
  - This obligation continues after termination of this agreement.
- 

## 8. Governing Law

- This Agreement shall be governed by the laws of the State of Illinois.
  - Any disputes shall be resolved in the jurisdiction of Cook County, IL.
- 

## 9. Non-Circumvention

Dispatcher agrees not to bypass Truck Driver Nation by working directly with referred operators outside of this agreement. Doing so will be considered a breach of contract.
