

# **TRUCK DRIVER NATION - PAY-AS-YOU-GO ENROLLMENT AGREEMENT AND COLLECTIONS RESPONSIBILITY CLAUSE**

This Pay-As-You-Go Enrollment Agreement ("Agreement") is entered into by and between **Truck Driver Nation** ("Company") and the undersigned student ("Student") for enrollment in the **Pay-As-You-Go Program** ("Program"). By signing below, the Student agrees to the terms and conditions set forth in this Agreement.

## **1. Payment Terms and Conditions**

The Student agrees to the payment schedule outlined in the **Pay-As-You-Go Payment Plan** provided by Truck Driver Nation. The Student shall make all payments on the agreed dates and amounts. Failure to comply with the payment schedule constitutes a violation of this Agreement.

## **2. Responsibility for Payment**

In the event that the Student fails to make a payment as required under the terms of this Agreement, and such failure results in Truck Driver Nation needing to engage a third-party collections agency, the Student agrees to be responsible for all costs associated with the collections process, including but not limited to:

- Collections fees
  - Legal fees
  - Court costs
  - Any other fees related to the collection of the outstanding balance

## **3. Default and Collections**

If the Student defaults on the payment plan, Truck Driver Nation reserves the right to refer the account to a collections agency. The Student acknowledges and agrees that, in such an event, they will be responsible for all costs incurred in the collections process, including the fees outlined in Section 2. The Student also acknowledges that their account may be reported to credit bureaus, which may negatively affect their credit score.

## **4. Acknowledgment of Debt Responsibility**

By signing this Agreement, the Student acknowledges that they understand and accept full responsibility for any and all fees and charges that may arise if the account is sent to collections. The Student further acknowledges that they have been informed of the potential consequences of non-payment, including but not limited to:

- Referral to a collections agency
- Additional collections-related fees
- Negative impact on their credit score

## 5. General Provisions

- **Entire Agreement:** This Agreement constitutes the entire understanding between the parties concerning the subject matter hereof. Any amendments must be in writing and signed by both parties.
- **Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the state in which Truck Driver Nation operates.
- **Severability:** If any provision of this Agreement is found to be invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

## 6. Student's Acknowledgment and Signature

By signing below, the Student acknowledges that they have read, understood, and agree to abide by the terms and conditions of this Agreement, including the collections responsibility clause. The Student further agrees to make timely payments according to the agreed-upon schedule and understands that failure to do so may result in additional fees and the involvement of a collections agency.
