### Program Payment Terms

- **Initial Enrollment Payment:** \$149 due at the time of signing this agreement.
- **Monthly Payments:** \$99 per month for four consecutive months, starting 30 days after the initial payment.
- **Total Program Cost:** \$600
- **Payment Schedule:**
  - \$99 - First monthly payment due 30 days after enrollment.
  - \$99 - Second monthly payment due 60 days after enrollment.
  - \$99 - Third monthly payment due 90 days after enrollment.
  - \$99 - Forth monthly payment due 120 days after enrollment.
  - \$55 - Final monthly payment due 150 days after enrollment.
- **Important Payment Notice – Pay-As-You-Go Option**

For every transaction processed under the Pay-As-You-Go plan, a **\$50 transaction fee** will be **automatically added** to the total amount due. This fee is applied **in addition to** the amount being charged for services or training.
- By proceeding with payment, the customer acknowledges and agrees to this additional fee.

### Late Fee Policy

Failure to honor any scheduled payment will result in a **\$25 late fee**. Late fees will be added to your account balance and must be paid in full to continue participation in the program. Missed payments beyond 15 days may result in suspension or termination from the program.
