

# Terms and Conditions – Pay-As-You-Go Enrollment Plan

## Truck Driver Nation Freight Dispatcher Certification Program

This agreement ("Agreement") is made and entered into by and between the participant ("Participant") and Truck Driver Nation, with respect to the enrollment in the Freight Dispatcher Certification Program under the "Pay As You Go" payment plan.

### 1. Enrollment and Payment Agreement

By enrolling in the Freight Dispatcher Certification Program under the "Pay As You Go" plan, you agree to the following terms and authorize Truck Driver Nation to charge your debit or credit card on file according to the agreed payment schedule.

### 2. Payment Structure

- **Initial Payment:** \$149 due at the time of enrollment. This payment is non-refundable and secures your place in the program.
- **Recurring Payments:**
  - \$99 automatically charged every 30 days, for four (4) months following the initial payment.
  - **Final Payment:** \$55 charged on the fifth month, completing the total program cost of \$600.
  - **Important Payment Notice – Pay-As-You-Go Option**  
For every transaction processed under the Pay-As-You-Go plan, a **\$50 transaction fee** will be **automatically added** to the total amount due. This fee is applied **in addition to** the amount being charged for services or training.
  - By proceeding with payment, the customer acknowledges and agrees to this additional fee.

### 3. Payment Method Requirement

Participants must provide a valid debit or credit card at the time of enrollment. This card will remain on file and will be used for scheduled payments unless updated by the participant.

### 4. Late or Failed Payments

Failure to honor scheduled payments will result in a **\$25 late fee** for each failed attempt. If payment fails more than twice, program access may be temporarily suspended until the account is brought current.

### 5. Completion and Certification

Certification will only be issued upon full payment of the program fee and successful completion of all course requirements, including a final exam with a minimum passing score of 85%.

## 6. Withdrawal and Refund Policy

All payments made under the “Pay As You Go” plan are non-refundable. Participants who withdraw before completing the program will still be held responsible for any remaining balance unless a written release is granted by Truck Driver Nation.
