- Submit **all rate confirmations** for loads moved by TDN-assigned Owner Operators to TDN within 24 hours of booking to Support@TruckDriverNation.com

#### 4. Penalty Clause

Failure to:

- Submit required rate confirmations,
- Maintain accurate daily reporting,
- Or remit the agreed 2% weekly fee to TDN,

will result in a \$250 per Owner Operator per week penalty fee, enforceable immediately. Repeated violations (2 or more weeks) may result in removal of all Owner Operators and legal collection proceedings.

Failure to provide accurate and timely revenue reports or to submit rate confirmations may result in:

- Temporary suspension of Owner Operator assignments.
- Termination of this agreement.
- Legal collection efforts for unpaid compensation.

#### 5. Termination

Either party may terminate this agreement with 7 days written notice. All outstanding payments and documents must be submitted within 5 days of termination notice.

### 6. Governing Law

This Agreement is governed by the laws of the State of Illinois.
