

EXTENSION AGREEMENT FOR TDN COURSE COMPLETION

This Extension Agreement ("Agreement") is entered into on **[Insert Date]** _____ by and between Truck Driver Nation ("Provider") and **[Insert Student's Full Name]** _____ ("Student").

RECITALS

WHEREAS, the Student has enrolled in the Truck Driver Nation dispatcher program (the "Program") and is bound by the terms of the original agreement signed upon enrollment; and

2. **Extension Fee**

3. **Obligation to Complete Program**

The Student acknowledges that failure to complete the Program within the extended period may result in loss of access to course materials and/or termination of the Student's enrollment in the Program.

4. **No Refunds**

The Student acknowledges that all fees paid under this Agreement, including but not limited to, the extension fee and any other charges, are non-refundable. The Student understands and agrees that upon receipt of digital content or access to course materials, no refunds will be provided under any circumstances, in accordance with the refund policy set forth by the Provider.

5. **Student's Responsibility**

The Student acknowledges that it is their responsibility to complete all course requirements within the extended period. The Student understands that failure to do so may result in the forfeiture of any rights to further extensions, participation in the Program, or any future support from the Provider.

6. **Legal and Binding Agreement**

By signing this Agreement, both parties affirm that they have read and understood the terms set forth herein. This Agreement is legally binding upon the Student upon execution and governs the relationship between the Provider and Student in regard to the extension of the Program. Any disputes regarding this Agreement will be subject to the laws of **Illinois**.

7. **Governing Law**

This Agreement will be governed by and construed in accordance with the laws of **Illinois**, without regard to its conflict of law provisions.

8. **Entire Agreement**

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written, relating to the subject matter hereof. Any amendments or modifications to this Agreement must be in writing and executed by both parties.
