Contractor shall not solicit or hire Truck Driver Nation personnel. Violation results in immediate termination and financial liability.

### 10. DATA COLLECTION & AUDIT CONSENT

Data may be used for training, compliance, legal protection, and performance review.

## 11. COMPLIANCE REQUIREMENTS

Failure to comply may result in immediate termination.

## 12. INSURANCE REQUIREMENTS

### 13. INDEMNIFICATION & HOLD HARMLESS

Upon termination: - Confidentiality obligations survive - All unpaid fees become immediately due - No refunds are owed

### 16. GOVERNING LAW (ALABAMA)

This Agreement is governed by and interpreted exclusively under the laws of the State of Alabama.

17. EXCLUSIVE COURT VENUE (HUNTSVILLE, AL)			
All legal actions arising from this Agreement shall be filed exclusively in Huntsville, Alabama, and Contractor submits to the jurisdiction of Alabama courts, waiving any objection to venue.			
18. DISPUTE RESOLUTION OPTION (ARBITRATION)			
Disputes may be resolved by binding arbitration seated in Huntsville, Alabama, at Truck Driver Nation's sole option. Judgment may be entered in Alabama courts.
