Ardleigh Parish Council Report


Our Parish Council usually meets on the second Monday of most months at Ardleigh Village Hall with a remote option for members of the public. Our meetings are open to the public, and there is a slot at each one for 'public participation' where residents can speak for up to three minutes. Outside this slot, members of the public are only permitted to speak if invited by the Chair. The next meeting will be Monday 11 March 2024, 7.30pm.

The February meeting was attended by Cllr Carlo Guglielmi, our Essex County Councillor and Cllr Zoe Fairley our Tendring District Councillor. Members of the public also attended both in person and online. The proposed Minerals Plan from Essex County Council was raised. This will be discussed in detail at a public **Minerals Plan Drop-In Workshop on Friday 1 March**, more details below. Other matters raised related to overgrowth blocking pavements, ditches, flooding and drainage and fly-tipping.

Budget and Council Tax 2024-25 The draft budget (and associated Council Tax/ Precept requirement) for 2024-25 agreed at an earlier meeting considered both the need to keep any increase low due to the continuing cost of living crisis, while meeting the needs of the Parish. The Council managed to set a balanced budget and agreed to a Precept of £81,077, which will cost a Band D household £70.13 per year, up £3.34 per year on last year, less than 7p extra per week.

Minerals Plan

New Mineral Extraction sites proposals in Ardleigh. An Essex County Council review includes 7 new potential sites (total 124.82ha) around Ardleigh, in addition to the 4 existing quarries.




Green shows the existing sites.

The map below includes other current proposals which are affecting the Parish of Ardleigh:

- <u>Purple line</u> is the proposed pylons route
- Black dotted line is proposed undergrounding route
- Mauve block is the proposed substation for National Grid
- Light green block is the proposed substation for Five Estuary / North Falls
- Brown is the proposed site for the Surya Warehouse

The cumulative impact of all of these developments would be enormous!

Judicial Review The process to challenge the Tendring District Council planning decision to approve the huge food storage and distribution facility adjacent to Wick Lane (20/00594/FUL) continues. Our specialist Planning Barrister, Simon Bell, will represent us at an oral permission hearing which will have happened by the time you read this. Several Ardleigh Parish Councillors will be in attendance. There will be an update in the next magazine.

Should permission be granted for a Judicial Review at the conclusion of the oral hearing, then more funds will be needed to argue our case at a full High Court hearing. We are grateful for the substantial donations which have enabled us to proceed to this position and are continuing to appeal for pledges of further support. Ardleigh Neighbourhood Plan The further consultation on matters which the Examiner had raised that needed addressing before the Examination could continue closes at **5pm on Monday 4 March 2024**. See *https://tendringdc.oc2.uk/.* Once this is complete our Parish Council should be given a further two weeks to respond to any comments received. Our main concern with the changes proposed by the Examiner is the proposal to remove the Garden Community development area (ie Crockleford) from the plan. This means that any additional protection or clarification afforded by the Neighbourhood Plan would not apply to our Crockleford residents.

Tendring/Colchester Borders Garden Community. Latimer, the developers of the Garden Community have indicated they will submit the first of their planning applications this summer. The design and number of dwellings in the initial phases may change from earlier proposals. You can view the latest documents and consultation boards via https://www.latimer.community/feedback.

The next stage will be a Stewardship Model for the area. We will aim to ensure that Crockleford remains within the Ardleigh Parish boundary and that all residents (old and new) have access to representation through a local council and not only residents' associations and management committees.

Although issues relating to the Compulsory Purchase orders for the new Link Road are ongoing, we understand that the route of the road has begun to be staked out around Allens Farm.

Pylons, Substations, Windfarms Action continues to fight against these plans coming to fruition. Many councillors attended the recent Five Estuaries webinar and subsequent consultation at Lawford Venture Centre. This was also attended by numerous members of the public. An Ardleigh History & Heritage Survey has been compiled to mark historic assets detailing the relationship to the planned siting of both pylons and substations.

Our MP Sir Bernard Jenkin remains publicly confident that an offshore option can be found and continues to meet with other Members of Parliament and the Electricity System Operator to discuss this.

Village Hall and Recreation Ground Car Park A meeting was requested to try to alleviate parking issues following reports of problems parking at the Hall and Recreation Ground, as well as along the road and pavement by the Hall. At this point, we are not able to update you, however, the Parish Council continues to ask residents and businesses to ensure that cars are parked in suitable authorised locations with full regard to the safety of residents and road users.

The Street Essex County Council were contacted about the surfacing works due to take place in The Street last year and queried whether the drainage problems in The Street could be rectified at the same time as the surface patching. Pictures were supplied by our Clerk. The request was put through by our County Councillor to the County Council maintenance team but unfortunately the engineer in charge advised the works were delayed due to other priorities. No alternative date has been announced. When the Council is updated with new dates, we will update our social media.

Dog Waste It has been reported by a member of the public, and by a councillor, that a significant amount of dog waste is being left on the playing fields and Millennium Green. **Please clear up after your dog.** There are a number of waste bins provided; this is not a dog problem, it is an owner problem! Please take note of what your dog is doing and **Bag It and Bin It**.

Maintaining Hedges/ Clearing Ditches It was mentioned previously that the Parish Council had received several complaints about footpaths being obstructed by hedges and hedges growing into roadways. This causes safety issues for both pedestrians and motorists. The Council sent a letter to householders/ landowners to request action be taken by them to mitigate these problems.

Thanks to those who received this letter and have subsequently cut back overgrown verges and hedges.

Complaints about overgrown hedges causing problems to footpaths or roadways should be reported to Essex Highways via <u>https://www.essexhighways.org/tell-us</u> *Please cut your hedges back as this helps keep roads and pavements safe for residents and road users.*

The Council has also received complaints about flooding from several residents with ditches being blocked. *Please clear ditches as necessary. Local floods are preventable if landowners keep on top of ditch and hedge maintenance.* Flooding should also be reported to Essex Highways via https://www.essexhighways.org/tell-us

Village Hall A survey has been done recently at the Village Hall in respect of whether there is RAAC present. An update will be given once the Council has received the results of the survey, but we are led to believe there is no obvious RAAC. We are also looking into options and potential grant funding for energy efficiency measures (including solar panels and roof repairs)
