19/036 Chairman's Welcome

The chair welcomed all those present.

19/037 Apologies and reasons for absence

The Council resolved to accept the apologies of Cllr Partridge, Thompson and Chase-

Gardener.

Cllr Fryer declared a pecuniary interest in Item 46 – Contract awards for The Tree Survey

A member of the public raised a complaint with the council and submitted the complaint in

writing to the clerk.

A further member of the public raised concerns about the large vehicles attempting to use Springvalley Lane, mistakenly thinking then can get to the businesses in Slough Lane. This has resulted in road closures as a vehicle got stranded on the very sharp bend; the destruction of the verges with mud now blocking the road side drains; vehicles leaving the road and general chaos. Springvalley lane is a protected lane as it has historic significance and has not been altered in character. It was said that there is an immediate need for

clear signage that makes clear that the lane is unsuitable for large vehicles.

There were no report to present however Cllr Gugliemli joined the meeting later and spoke to the following:

Home Farm Lane – update on meeting with Peake Fruit about traffic management which will result in a Local Highways Panel request for additional road signage. Peake Fruit

intend to provide an improved area for delivery management as part of the refrigeration unit development. The situation needs to be monitored carefully to see that this is satisfactory.

Cllr Gugliemli also asked the parish council write formally requesting TDC consider protecting Wick Lane as part of the emerging Local Plan as ECC have removed County level protected status.

Cllr Gugliemli asked the parish council write formally advising of the Springvalley Lane problems.
