Chairman's Welcome

The Chairman welcomed everyone to the meeting.

17/0159 Apologies for absence

Cllr's Partridge and Smith sent apologies.

17/0160 Declaration of Interests - to receive any pecuniary or non-pecuniary interests relating to

items on the agenda.

17/0161 Public participation session with respect to items on the agenda and other matters that

are of mutual interest.

The public participation session included an introduction to the Reverend Antony Wilson who covers both Dedham and Ardleigh Parishes. Rev Wilson is intruding a number of children and family services to both churches and will be conducting the remembrance service at Ardleigh St Mary's Church in November.

A member of the public raised the issue of bees kept locally and Cllr Andrews was able to advise on good beekeeping practice.

The Council thanked SRC Aggregates and Recycled in Ardleigh who have recently sponsored floral barrels in the village.

The Council agreed the draft minutes of the meeting were a true and accurate account of the proceedings.

17/0163 Clerk's Report

The Council received the report of resolutions agreed at previous Parish Council Meetings and noted action to date.

It was noted that the Council had been successful in securing S106 funding from Tendring Parish Council for the Colchester Road Play Area.

17/0164 District and County Councillor Reports

Cllr Stock and Cllr Gugliemli were absent and the Clerk had circulated the Essex County report prior to the meeting.

17/0165 **Planning**

17/165.1 To update the meeting on the site visit of TDC to the Wick Lane/Old Ipswich Road application 17/00976/Ful – APC requested application be 'called in'.

Cllr Chase-Gardener reported that the site visit of TDC to Wick Lane to see the problems with the proposed application including vehicle access from Wick Lane had been helpful as TDC were able to see the difficulty with Wick Lane for vehicle. It is understood that TDC will form a working group to include Ardleigh Council to work with the applicants to revert back to the original proposal with access to and from the site from the Old Ipswich Road.

It was also reported that TDC said that Wick Lanes protected status was no longer in place. It was agreed to investigate this is as Ardleigh Parish had not been informed of the case to remove protected status.

17/165.2 To note the verbal report of the meeting of councillors with the builders of Avellena Phase 2 on the Land to the North of the former Betts Factory.

The Council reported that a meeting with Strutt Parker, Bellway Homes and the landscaping representative had taken place to discuss the proposed layout, density and landscaping for Phase 2 of the Avellena Place development which is already passed at outline planning permission and will be submitted for detailed planning shortly.

17/0166 **Churchyard & Cemetery**

17/166.1 To receive reports and consider any decisions on expenditure.

> The reports were received with comments on the dead tree in the churchyard, fungus living on some dead wood, a dead bush close to one grave and some litter.

> In the cemetery there is a dead branch to a tall pine tree and a comment that the gates/metal fencing need refurbishing and a hole near a gravestone in the older part of the cemetery.

It was also agreed that the Council would look to find a local war memorial restorer.

17/0167 Recreation, Play and Open Spaces & Colchester Road Play Area

17/167.1 To receive reports on condition of area and identify any health and safety risks and

consider any decisions for expenditure.

It was reported that the aerial runway and teen shelter would be installed on the Millennium Green towards the end of September. The company would be siting a large container on the Recreation Ground car park and would need access to the changing room toilets.

The Under 12's exercise equipment of 6 pieces, a bench and a sign was to be installed just beyond the entrance to the Millennium Green. The cost of the additional equipment would be paid for by the Council and the GCG Trust would donate £10,000 to cover the cost. The Council expressed a vote of thanks to the GCG Trust for facilitating this.

17/0168 Environment and maintenance

17/168.1 To receive any reports and consider decisions for expenditure.

It was noted that there are some dead trees/shrubs on the Millennium Green and two new benches were required to replace broken benches.

Cllr Thompson agreed to look into refurbishing the beacon so that it can be used in 2018.

It was also reported that the grass cutting for the year had been carried out.

It was also suggested that the village would benefit from vegetation being cut back and the taking away low lying branches of the tree at Oak Tree Corner. It was agreed that this should be costed.

Three signs are missing or damaged in the village – the bend sign between the village and the Essex Sal Depot and also the sign on the A137 opposite Wick Lane entrance where a car has demolished the sign. The school crossing sign is also broken. The Clerk was asked to report these.

It was also noted that the road side hedge alongside the village hall needs to be cut back and it was agreed to ask BLand Landscapes to do this.

17/168.2 To consider any action that can be taken to deter fly-tipping.

Incidents of fly-tipping are continuing are Cllr Marshall asked if ECC could be approached to see if 'No Fly-Tipping' signs/boards were still available.

It was reported that after receiving a letter from the Office of The Traffic Commissioner explaining that they couldn't help on the issue of HGVs travelling along weight restricted roads, the Council had met with ECC and Cllr Gugliemli which had been helpful in raising the issue and the Council is waiting to see if the weight restricted area would be amended as suggested by Ardleigh Parish Council.
