18/076 Apologies and reasons for absence

Cllr's Partridge was absent from the meeting having submitted his apologies..

Cllr's Gugliemli and Stock (ECC and TDC respectively) were also absent.

18/081 Public participation session with respect to items on the agenda and other matters that are of mutual interest

A local student spoke of his planned charity expedition to Kenya in 2019 and was seeking a donation towards his target. There were a number of suggestions from the Council and members of the public on fundraising opportunities that could be undertaken.

The traffic in the village is causing a nuisance at night with loud vehicles screeching along the A137 at speed. The Council agreed to approach the Local Highways Panel to see what could be done to curb speeding along the A137.

The issue of litter along the Old Ipswich Rd was raised as the cars park along that stretch of road all week and seem to empty their cars of litter onto the roadside before leaving. The council agreed to approach the Local Highways Panel to see what could be done to

dissuade littering.

It was confirmed that the local Speedwatch group would be commencing soon, during daylight hours only, with one site approved and a further 3 possible sites being considered.

It was reported that a car using Blacksmiths Lane narrowly missed a pedestrian recently. The Council confirmed that Blacksmiths Lane is a footpath and unless the car user has authority to drive over it (through TDC or via the land owner) then they should not be driving vehicles along the lane. The Council agreed to investigate the permissions in place.

The village archivist presented the draft art work for the Ardleigh In Wartime memorial which is being funded by the GCG Trust. The Parish Council very much support and approve the memorial and the planned village activity days.

18/082 Minutes of the last meeting of the Council held on 9 April 2018.

The clerk's report was presented and accepted. It was reported that the item at 18/66.1 had been rectified by Highways.

18/085 **Planning**

To discuss progress re Peake Fruit Refrigeration unit.

It had been reported that after securing planning consent to site a refrigeration unit at Peake Fruit there had been a discovery of a high pressure sewer. The Council commented that a change of planning consent may be required and if so a 2nd approach to TDC to state that this application should not be approved because of the HGV/LGV congestion already occurring along Home Farm Lane.

18/086 Churchyard & Cemetery

To receive reports and consider any decisions on expenditure.

It was reported that the Cemetery gates need attention and where the large tree had been removed the area needed seeding. Cllr Barrott commented that grave diggers were using that area to dump the removed soil instead of taking it away. It was decided to write to the regular funeral directors reminding them that they are responsible for ensuring that top soil is removed.

A headstone inscription was approved.

18/87.1 To receive reports on condition of area and identify any health and saf

It was reported that a scramble net joint needed replacing but after discussion it was

decided that the Millennium Green Trust would arrange for the whole net to be replaced.

To note the intended start date for the Colchester Road play area fencing works to start by mid-May.

This was noted.

To decide if any action can be taken to deter evening and night time gatherings on the Recreation Ground car park.

It was decided that putting in a higher speed bump would not be a deterrent and might damage legitimate users of the Recreation Ground Car Park. It was decided to investigate CCTV with appropriate signage.

To consider request for small piece of Recreation Ground land on car park (see attachment).

In order to consider this request the Trust documents need to be read to understand if a sale would be permissible.

18/088 Environment and maintenance

18/88.1 To receive reports and consider any decisions for expenditure.

It was noted that the Ardleigh Depot had not yet arranged a meeting to discuss the lighting.

It was also reported that the warning signs had been knocked over by the primary school and would be reported to Highways.

It was noted that part of the see-through window of the bus shelter at Burnt Heath was fractured and the Clerk was asked to request Roalco to repair.

18/88.2 To note that the Council had received no bids for the Handyman contract advertised.

This was noted and it was decided to try again later in the year.

18/089 Public Rights of Way

18/89.1 To receive reports and consider any decisions for expenditure.

The issue of cars travelling along the public footpath that is Blacksmiths Lane had been raised in the Public Participation session of the meeting. The Council agreed to conduct Land Registry searches to establish if any property had legitimate use of the lane by vehicle.

18/090 Funding Requests

18/90.1 To note the Dictaphone for the Speed Awareness Team was purchased.

This was noted.

^{18/90.2} To consider a funding request from an Ardleigh student.

This was considered but decided against as the Council did not feel that it was a good use of local tax payers money. It was decided that the application should be passed to the Ardleigh Parochial Charity.

To note the application to the GCG Trust for £3912.00 to cover the cost of the outside works adjacent to the Village Hall. This will allow the bills of £436.00 = VAT and £3476.00 + VAT to be paid.

This was noted.

18/091 Car Rally

To note that the organiser of the Corbeau Seats Car Rally held in Tendring on 22nd April 2018 is attending the June Parish Council meeting.

There was a view expressed that said that the car rally was inconvenient to locals with

road closures for the day and with no benefit to Ardleigh. There had been the added frustration of individuals trying to race the route before the event.

One of the local landowners had equipment and rally staff positioned in a field they own without permission which should have been resolved before the event.

The rally organisers had sent a magazine article to the council for comment and Cllr Barrott agreed to review and pass to the Ardleigh Advertiser.

18/092 Ardleigh Memorial Events

To receive a verbal report on the Ardleigh Memorial and Ringing for Peace events.

An Ardleigh family fun day is planned for Saturday 8^{th} September and an Ardleigh in Wartime Memorial dedication service planned for 30^{th} September. The Beacon would be lit on Remembrance Day November 11^{th} at 7.06pm followed by a ringing of the Church bells as part of the Ringing for Peace event. It was agreed to book adequate first aid coverage for the Sep 8^{th} fun day for the Village Hall, Recreation Ground and Millennium Green from 12-4pm.

18/093 TDALC

To receive any report or minutes from latest meetings.

The next TDALC meeting is later this month. Cllr Halsey was asked to raise the issue of speeding vehicles.

18/094 Annual Assembly

To decide on any suggested changes to the Annual Assembly format.

The advantages of booking a community speaker was discussed and agreed to be a good idea.
