Adopter understands that should violations of the contract occur, the Organization reserves the right to enter the property at any time without cause or warrant and take immediate physical possession of said horse without recourse from Adopter. |

Adopter will accept all responsibility for any action or lien resulting from any action, directly or indirectly involving said horse while it is in Adopter's possession and under Adopter's care and control. Therefore, Adopter agrees and understands that neither the Organization nor its employees or agents will be liable for any damages or injury caused to Adopter or any third person by the equine once Adopter receives delivery of the equine, including but not limited to damages or injuries caused by the fact that the equine does not behave or perform in the manner Adopter expected. Further, if any third person makes a claim against the Organization or any of its employees or agents as a result of any conduct of the equine after Adopter has taken possession of the equine, Adopter agrees to indemnify and hold the Organization, its employees and agent harmless from any such claims, including costs and attorney's fee resulting from such claim. |
