THIS ADOPTION AGREEMENT is made between the Easy Street Animal Shelter (“Shelter”) and the individual whose signature appears below (“Adopter”).

- A. Adopter desires to adopt the animal identified above from Easy Street Animal Shelter; and
- B. The Easy Street Animal Shelter to give the Animal to Adopter for adoption.
- C. In consideration of the mutual promises contained herein, Adopter and Easy Street Animal Shelter hereby agree as Follows:

1. Adopter shall provide the Animal with proper and humane care, food, water, shelter, exercise and supervision. Adopter accepts the Animal as a pet and companion, and agrees not to keep the Animal outdoors or an outdoor porch or chain, nor to confine the Animal to a room whether the room is indoors or outdoors, nor to be used solely as a guard dog, a fighting dog, or for experimentation or research.
2. Adopter agrees that in the event the adopter is unable or unwell in to care for the Animal, Adopter shall, at his/her own expense, promptly return the animal to the Easy Street Animal Shelter.
3. Adopter shall provide the Animal with proper veterinary care both on a regular basis including yearly checkups, vaccinations and heartworm prevention, and if the Animal becomes ill or injured. Adopter agrees to comply with all city, county, state and federal laws relating to treatment. If the Animal is younger than 6 months of age at the time of adoption, the Adopter agrees to have the Animal spayed or neutered when the Animal is 6 months of age.
4. The undersigned hereby fully and forever releases and discharges the Easy Street Animal Shelter from any and all causes of action, claims and demands for, upon, or by reason of any personal injuries and losses of damage to property which may hereafter be sustained as a consequence of, arising out of, or incurred in connection with ownership of the Animal described above. It is further agreed that the undersigned hereby agrees to hold harmless and to indemnify the Easy Street Animal Shelter from any and all expenses arising out of or incurred in connection with, any claim which may hereafter be presented by anyone of loss and damage to property or personal injury as a result of the ownership of the animal described above.
