March 29, 1969

General

The Assembly accepted the following two recommendations and recommended that Delegate vote **FOR** the two measurers:

- 1. At this panel's request, World Service Office agreed to have Conference study the procedures of nominating area trustees. Panel or area is going to recommend that states which have more than one area such as California with five be able to send a nomination from each area that wishes to do so instead of only one nomination from each state regardless of is size or population.
- 2. All areas would be expected to pay a set amount to send their delegate to the Conference.

A motion was made and carried for a new organization structure of AA which would combine all AA service chairmen such as Intergroups, H&I Committees and local Convention Committees; Young People's Groups; and General Service Assemblies; and yet each would be autonomous as state in Tradition 4; allowing each Service a direct line of communication to the General Service Conference and Alcoholics Anonymous World Services (AAWS).
