 - o Simple majority the motion C will move to the May Assembly

May 19, 2024

- Motion A: On behalf of Area 09, Panel 72 Executive Board, I motion that Mid-Southern California Area 09 (MSCA 09) consider –beginning with Panel 74, holding all Area Service Committee meetings within the four corners of MSCA 09 and the Area Service Assemblies (ASAs) in one of two central locations.
 - Speaker: Our group felt it was important to have a centralized location. Having facility that would support hybrid would be great.
 - o Speaker: Asked if only GSR give opinion.
 - O Speaker: Is in favor because that is close to ocean and one east would be helpful. Because of hybrid a location with good amenities would be best.
 - o Speaker: In favor because we need a good place with good bandwidth and reliable.
 - o Speaker: Central location would be Riverside.

- O Speaker: I am against this motion but there are many factors that we are not considering and I know that I will not have enough time to explain the factors but one of them that the further districts are deprived of the opportunity because doing this in person and further away would allow more people to participate. So, we have other ways to deal with it. This past Jan failed because we relied too much of internet.
- Speaker: We voted that our meetings were hybrid. So, meetings must have reliable areas. Having the four venues secured will allow a good hybrid but also a fixed cost for venues.
- o Speaker: College of the Desert is not set up to handle an area meeting.
- O Speaker: My members are against this motion because they are not considering the new GSR we are focusing a lot on internet and places.
- Speaker: Supports motion that takes financial responsibility away from the host.
 Once a venue is secured then we could have a set budget.
- Motion passes.
- o Minority opinion:
- o Speaker: I think that the people online should not vote only in person.
- Speaker: If the problem that is trying to get stable internet. 2nd is the most fun is hosting an event such as this. If that is the case, then the area should fully let the board take full responsibility.

- O Speaker: If this motion is for only 2024 then it doesn't matter.
- Speaker: Our treasurer reminds us of that GSO is having money crisis. I remember that GSO sent us information about month of gratitude but have not received any finances from GSO.
- o Delegate responded that GSO finances are located on delegate page.
- O Speaker: I am in favor of supporting this because I think we can invest more.
- O Speaker: Not in favor because it will take more finances.
- Speaker: Question is if we do not vote to supply whole amount, then who pays.
 Rozanne answered that GSO votes.
- o Speaker: Our guidelines say that only the GSR and DCM can vote.

- o Speaker: Against that. GSO should pay.
- O Speaker: Against the motion because NY does not need any more of our money.
- Motion does not pass.
