President's Message

"When Will Voters Say: 'Enough is Enough'?"

In just a few weeks, voters will receive their ballots for the upcoming November election. In addition to the critical candidate races, there are numerous propositions to consider. For example, two bond proposals of \$10 billion each (Propositions 2 and 4) must be carefully evaluated. The marketing strategies to persuade you, the voter, to approve these excessive propositions will undoubtedly appeal to your emotions.

The biggest threat, however, to California property owners is Proposition 5. If approved, it would lower the voter threshold for passing bond measures from two-thirds (66 2/3%) to just 55%. This means only 55% of voters would be required to pass bonds, instead of the current 66 2/3%.

As Susan Shelley of the Howard Jarvis Taxpayers Association (HJTA) says, Prop 5 is "like a turbo engine" for raising property taxes whenever government agencies want. Proposition 5 would make it easier for local governments to increase your property taxes. This measure bypasses Proposition 13's limits on property tax hikes by making it easier to pass bonds—a form of borrowing money that is repaid, with interest, by adding extra charges to property tax bills, sometimes for decades.

When property taxes rise, there is little consideration for a homeowner's ability to pay, or any financial hardship or disability. If homeowners fall behind on their property taxes, their homes can be sold out from under them.

Lowering the voter threshold only benefits the government. It's actions like this that show the lack of fiscal responsibility on the part of state officials. Where is the accountability, especially when the state faces a deficit beyond imagination? Where is the money going? If Proposition 5 passes, it will open the floodgates to continued property tax hikes in future elections. It will also make it easier for the government to borrow money for "public infrastructure," which includes everything from facilities, parks, and emergency services to transit improvements, libraries, and ports. The lower vote threshold would also apply to new debt. And it's not just cities and counties that could take on debt...so could "a transit district, a regional transportation commission, and an association of governments."

With rising property taxes, tenants will experience higher rents as landlords pass on the increased costs of providing rental housing. Even small businesses will face rent hikes as commercial tenants are forced to shoulder the burden of higher property taxes.

Let's face it: when it becomes easier to borrow money, some elected officials are likely to spend existing tax revenues on everything except high-priority needs. In the coming years, municipal budgets could become increasingly strained as more revenue is diverted to repay investors for old debt.

Early Californians understood the importance of controlling debt. The requirement of a two-thirds vote to pass local bonds is a crucial protection for California residents, now and in the future.



So, when will this irresponsible borrowing from tax payers end?

Dr. Aaron Kheriaty Update: **Guess Who's Coming to Dinner?**

This is an update to the article about Dr. Aaron Kheriaty that I wrote for our [May newsletter](#).

Last May, Dr. Kheriaty and his co-plaintiffs were waiting for the Supreme Court to rule on their landmark First Amendment case *Missouri v. Biden*. (Or *Murthy v. Missouri*, as the case was re-named when it reached the Supreme Court). They were fighting the actions of the Biden administration to coerce tech companies into censoring the internet communications of US citizens. Unfortunately, the Court punted and in late June ruled that the plaintiffs did not have standing.

Phillip Hamburger, whose civil rights organization, the [New Civil Liberties Alliance](#), represented the plaintiffs in *Murthy v. Missouri*, has called the ruling the "worst speech decision in the court's history..." He said it "hammered home the distressing conclusion that, under the court's doctrines, the First Amendment is, for all practical purposes, unenforceable against large-scale [government censorship](#)."

Indeed, as soon as the ruling came down, the Biden-Harris administration redoubled its coercive tactics, the same ones laid bare by the [Twitter Files](#). It has since been suppressing free speech on every Big Tech platform which will go along with it. Only Elon Musk's X and other smaller alternative media platforms have stood against them.

Of course they *must* do this ahead of the November 5 election. If the public knew the truth about the Deep State, there is no way the Democrats could win. Governments always censor truth, not lies.

Fortunately, there is still hope.

On August 26 Dr. Kheriaty used his [Substack Human Flourishing to announce](#) that an unexpected co-plaintiff had joined his First Amendment lawsuit: "...Robert F. Kennedy Jr.'s companion lawsuit *Kennedy v. Biden* has been consolidated by the court into our *Missouri v. Biden* case. Based upon documents we obtained on discovery, the court recently found that Kennedy meets the Supreme Court's stringent standing criteria. We only need one co-plaintiff with standing to bring the case and the petition for the injunction. So the injunction is back in play, and we will likely find ourselves at the Supreme Court again in a few months."

When Dr. Kheriaty et al. return to the Supreme Court with their new co-plaintiff, we can all pray that the six majority opinion justices will have had more time to read the brilliant [dissenting opinion](#) of Justice Samuel Alito. We can hope that they will recognize that the Biden-Harris "government engaged in unconstitutional censorship on a mass scale." Unless those justices reverse their opinion and decide to protect freedom of speech in the digital forum, our First Amendment and all the other rights that depend on it will be headed for oblivion.

In his Substack Dr. Kheriaty also mentioned RFK Jr.'s decision on August 23 to suspend his campaign and endorse President Trump. He rightly noted that Kennedy's "48-minute [speech](#) announcing this decision was an extraordinary moment in American politics and is worth watching." Much as I enjoy President Trump's relaxed mode of speaking, I must admit that Kennedy's speech quelled an itch for classical rhetorical style that had not been scratched in a long time.

Kennedy laid out the top three issues that motivate him in careful detail. Censorship was at the top of the list, which is not surprising, given that he comes from a family that excelled in debate and the exchange of ideas. He knows how to value free speech.

Secondly, he wants to eliminate unnecessary overseas spending and involvement in foreign wars.

Finally, he wants to restore the health of our children and of the American people in general, which has degraded so much in the past 50 years. He calls this policy the MAHA movement: Make America Healthy Again.

The attempted assassination of President Trump on July 13 could not have failed to stir the cords of memory in a man who had been 14 when he witnessed his father's assassination. Shortly thereafter he agreed to meet with Trump and the two discovered how much they had in common.

Though much still divides the two men, they have chosen to work together to bring about the policies they both support. More and more Democrats and Independents are joining the MAGA coalition of common sense: witness Tulsi Gabbard, Nicole Shanahan, Amber Rose, Gloria Romero, and countless others.

The question is, will we in the America First movement be ready to welcome the new guests at our table with respect and understanding?

Article II of the Constitution Establishes the Executive Branch & the Electoral College **(How does that work?): Lesson IV**

In Federalist 39, James Madison defines a republic (or republican form of government) as one that derives all its powers **directly or indirectly** from the great body of the people" (emphasis mine). Why do I begin our examination of Article II of the U.S. Constitution thus? Because although Section 1 of Article II vests the executive authority in a President, it also describes the way the executive is to be elected, the electoral college.

The founders understood well that each state, regardless of size or population, must have a say in the election of the President. Without a voice in the decision, the legitimacy of the presidency itself would be at risk. Today, for example, were the president chosen by popular vote (majority wins), New York, Texas, Florida and California would decide, and the remainder of the country would be silenced. **With the electoral college, the people choose the president indirectly** and we get a broad perspective on what the people generally want and what each state wants, in keeping with our federalist system.

Here is how it works: when you vote for the president, you are not voting for the person running; rather, you are voting for the electors, chosen by the candidate's political party. Each state is allowed one electoral vote for each of its U.S. Senators and one for each of its members (or member) in the House of Representative. California, for example has 2 electoral votes for each Senator and 52 for each member of the state's congressional delegation to the House for a total of 54 electoral votes (we lost one House member to the exodus of Californians to Red states). All of California's 54 electoral votes go to either the Democratic candidate or the Republican candidate. Wyoming, the state with the least population in the country, has 3 electoral votes – two for each Senator and one for their lone member of the House.

There are 538 electoral votes cast by electors in December (yes, December, not November). There are 100 Senators, 435 members of the House of Representatives and three delegates representing Washington, D. C., for a total of 538. In the tally of the electoral college a simple majority wins. Let's do the math: 538 divided by 2 is 269, plus one = 270. It takes 270 electoral votes to win the presidential election, that's it, once the count gets to 270 the election is over. Unfortunately for California, our 54 electoral votes are wrapped up by the Democrats, given that approximately 47% of registered voters are Democrats, 24% are Republicans and 22.23% are No Party Preference with about 7% self-declared as "other". (<https://elections.cdn.sos.ca.gov/ror/154day-presprim-2024/historical-reg-stats.pdf>).



The remainder of Article I establishes the age requirement for the president and adds a caveat that the other three branches do not have and that is that the president must be a natural born citizen and cannot be an immigrant. Included is the presidential oath of office, which by the way, does not require fealty to the country itself but to "preserve, protect and defend the Constitution." The president is granted the role of the commander and chief of all branches of the military, the power to appoint and nominate members of the Supreme Court. The formidable powers he is granted are in some cases tempered by the "Advice and Consent" he must seek from the Senate.

Article I is an easy read, so do it. But keep in mind that George Washington could have been a king and chose not to accept such a role. In America we avoid adulation of the man or woman per se. While we may be pleased when our candidate is elected president, it is the office itself and not the cult of any one person that enthalls the

people. Portraits of our president are not ubiquitous and posted in public places, such as is done in countries with authoritarian executives. **The Framers thought it important that the United States not have an aristocracy, nor a monarch.**

Next month we will discuss more about the Executive Branch and what has come to be known as the Administrative State.

Kamala Harris and the Crime That Must Not Be Named

Have you ever met a celebrity? Given the make-up of our club, I'm sure that most of you have. Celebrities from the worlds of sports, entertainment, and of course, politics, have no doubt crossed your paths. Not mine. Being a nerd, my closest encounters with fame have been from the world of poetry: I knew Dana Gioia back before he was named Poet Laureate, and I once gave a ride to Octavio Paz and his wife in the back of my VW Bug.

OK, so maybe the poets Gioia and Paz are not household names.

I'm racking my brains; have I ever met anyone famous?

Nope.

Well, what about the near-famous: people in the public square who have earned at least some degree of recognition for their outsized contributions? In that case, yes: Aaron Kheriaty.

Dr. Aaron Kheriaty spoke to our club in 2023 about his fight against vaccine mandates and his Supreme Court battle for free speech in *Missouri v. Biden*. For more info about him see my article in our May 2024 [newsletter](#). After the club meeting I was able to exchange a few words with him and have him sign my copy of his book, *The New Abnormal: The Rise of the Biomedical Security State*. How incredibly lucky I felt to meet one of the foremost fighters of our day in the battle for medical autonomy and freedom of speech. Although I'm sure it's exciting to encounter someone considered by the popular culture to be a bona fide celebrity, I believe that Dr. Kheriaty and his co-plaintiffs present a much better case to be widely known and celebrated. (*I have an update about him in this issue*).

It was way back in 2012 when I met another man in this category—a person in the public square who deserves to be better known. David Daleiden is an Orange County resident who is arguably one of the top victims of Kamala Harris's misuse of her high office as Attorney General for the State of California. He, better than most, is qualified to say what life would be like under a President Harris.

I was living in the Bay Area when I was introduced to Daleiden at a meeting of 40 Days for Life participants. Some of you may know this organization from the movie *Unplanned*. Our mission was to peacefully pray in front of a Planned Parenthood clinic in San Jose. Most of the crowd was older—there were many gray heads—and so we were excited to see several young people from Live Action in attendance. [Live Action](#) is a pro-life group that does undercover investigations. It was founded by another Orange County resident, Lila Rose. As with the broader patriot movement in the US, pro-life groups tend to form a mosaic of interlocking coalitions.

Daleiden was then a member of Live Action, just 23 years old. He asked me about my activities with 40 Days, but I could tell, even as he listened politely, that his mind was focused somewhere ahead. His cause was clearly driving him, and he was the very epitome of a young man on a mission. Normally I have difficulty recalling names, but this time I made a point to learn the spelling and pronunciation. I knew I would hear about him again.

I didn't have long to wait. In 2013 Daleiden started [The Center for Medical Progress](#) in Orange County and began work as a citizen journalist investigating Planned Parenthood for its sale of aborted fetal body parts. Such commerce was strictly prohibited under federal law, and still is, but most people in the prolife movement knew that it was going on clandestinely. Daleiden's task was to film a series of undercover videos that brought undeniable evidence that many Planned Parenthood employees were involved in this repugnant trade. He also exposed the companies that were their customers.

In 2015 Daleiden began to publish the [videos](#) on the internet. They created an uproar that was widely covered in the press. By early 2016 so much damage had been done to Planned Parenthood's image that their champion Kamala Harris, then Attorney General of California, sent eleven armed agents of the California Department of Justice to raid Daleiden's small apartment in Orange County. They seized his video equipment and computers, with the aim of scrubbing his videos from the internet and [suppressing any further releases](#).

Kamala Harris had organized this raid two weeks before with Planned Parenthood employees in attendance at the meeting. She was running for the U.S. Senate at the time, and Planned Parenthood was one of her big donors; she also fundraised off her support for them. Did she see any reason to recuse herself from the case? Of course not.

Daleiden had exposed an outrageous breach of federal law, but Kamala ignored whistleblower protections and prosecuted him for breaking California's video recording laws. When she headed for the Senate, Harris passed the prosecution along to AG Xavier Becerra. Since that time, Daleiden has waged a nine-year legal battle which is still ongoing. He faces a nearly \$25 million fine and many years in prison. The case is a candidate to reach the Supreme Court.

In addition to the tremendous personal cost for Daleiden, there is a concern for the future of freedom of the press if this [legal judgement stands](#). Since the conversations with Planned Parenthood employees were filmed in public spaces, the subjects had no basis to assume privacy, and no other journalist has ever been prosecuted under California law for such recordings. In an appeal to the Ninth Circuit, Daleiden's attorneys stated that "the judgment is not only an affront to the rule of law, but it threatens the existence of undercover journalism itself, a critical means to effect societal change."

In a 2021 [review](#) of Daleiden's case, the Ethics and Public Policy Center wrote that "it is worth comparing the treatment he and his colleagues have received for their undercover campaign with the reception given to animal-rights activists who expose how animals are mistreated at factory farms or other food-production plants." PETA and the Humane Society and other animal welfare groups have never been prosecuted for their exposés, but instead are routinely rewarded with judgements against animal abusers.

Showing incredible fortitude, Daleiden has persevered in his work with the Center for Medical Progress. He has also brought a federal lawsuit against Kamala Harris for her violation of his First Amendment civil rights. Now that Harris is running for President, Daleiden feels that it is essential for Americans to understand her true character.

You need to remember this and pass it along: beginning in 2016, CA Attorney General Harris pioneered the use of lawfare and censorship to punish and silence a brave young journalist on behalf of a corrupt big donor. We saw how those same weapons have been used on an unbelievably broad scale against President Trump and against hundreds of ordinary citizens during the three and a half years of the Biden-Harris administration. It's not hard to imagine that the lawfare and censorship would keep increasing under a President Harris until we reached the status of a total police state.

Kamala Harris was fine with the Planned Parenthood [abortion van](#) parked at this summer's Democrat Convention. But even *she* believes that some crimes are so unmentionable that journalists who expose them must be silenced and imprisoned. All the more reason to shout them from the rooftops.





Conservative Movies are Making the Rounds!

Several movies are getting great reviews and publicity, and believe it or not, they are conservative productions!

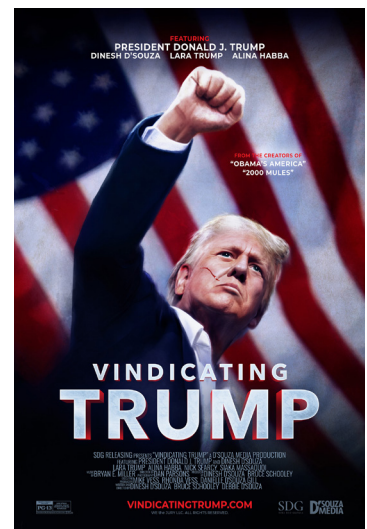
