President's Message

"The Power of the Pen: How Our Local Voices Are Being Silenced"

In a growing trend of legislative overreach, the state government is steadily dismantling the authority of local communities when it comes to land use and planning. The language used in some of the latest housing bills reveals a calculated effort to centralize power and eliminate local input — effectively stripping away the ability of cities and counties to shape their own neighborhoods.



Take **SB 677**, for example — a bill pitched as a way to “streamline housing development.” But a closer look reveals a pattern of forced compliance and weakened local oversight. Here are just a few excerpts that show how local control is being systematically eroded:

1. From Local Discretion to State Mandates

“Existing law prohibits ministerial approval for proposed housing...”

“This bill would require ministerial approval for proposed...”

Translation? Cities would be forced to approve certain developments automatically, regardless of local zoning concerns, infrastructure capacity, or neighborhood input.

2. Undermining Local Zoning Authority

“Existing law authorizes a local agency to impose objective zoning standards...”

“This bill would provide an exception...”

Once again, the state overrides long-standing local zoning protections in the name of “streamlining.”

3. Erasing Local Ordinances

“Existing law authorizes a local agency to adopt an ordinance to implement these provisions...”

“This bill would revise and recast those provisions...”

In other words, your community’s carefully crafted land use policies could be rewritten or nullified by Sacramento.

4. Shifting the Burden of Proof

“This bill would require the local government to bear the burden of proof...”

“...to demonstrate, with a preponderance of the evidence, that the development does not comply...”

The law stacks the deck against local governments. Instead of developers proving their projects meet environmental standards, cities must now prove that they don’t — a costly and uphill battle that favors special interests.

What This Means for You

This is not just about housing. It’s about **who decides what gets built in your neighborhood** — you and your elected local officials, or a one-size-fits-all mandate from the state.

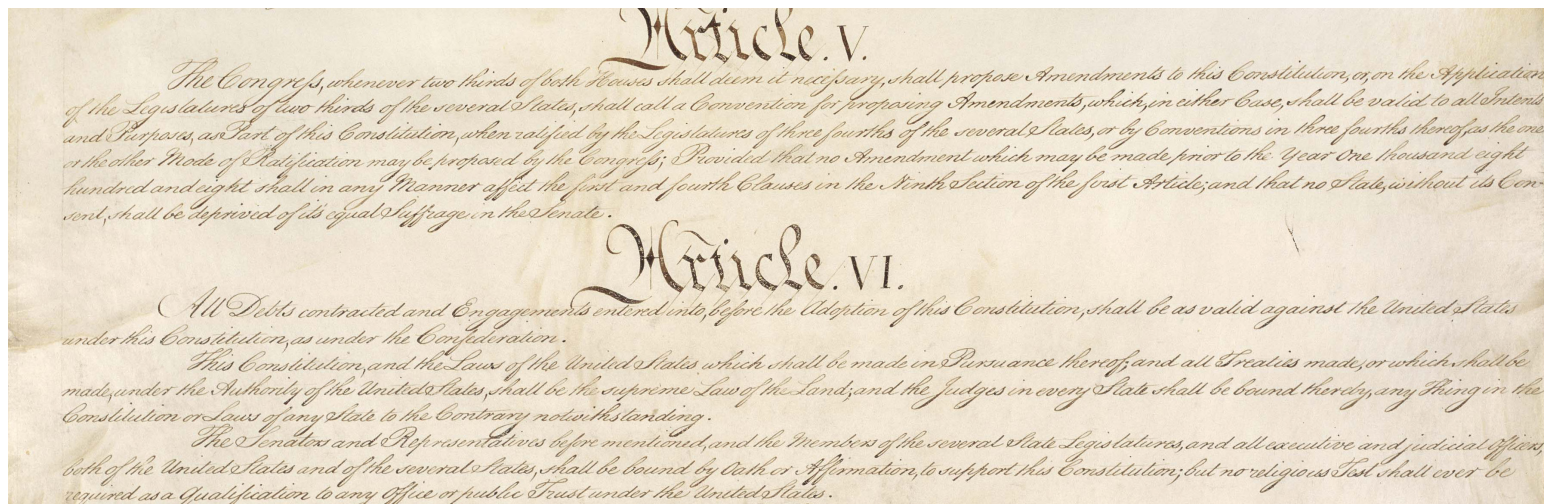

The Fifth and Sixth Amendments to the U.S. Constitution

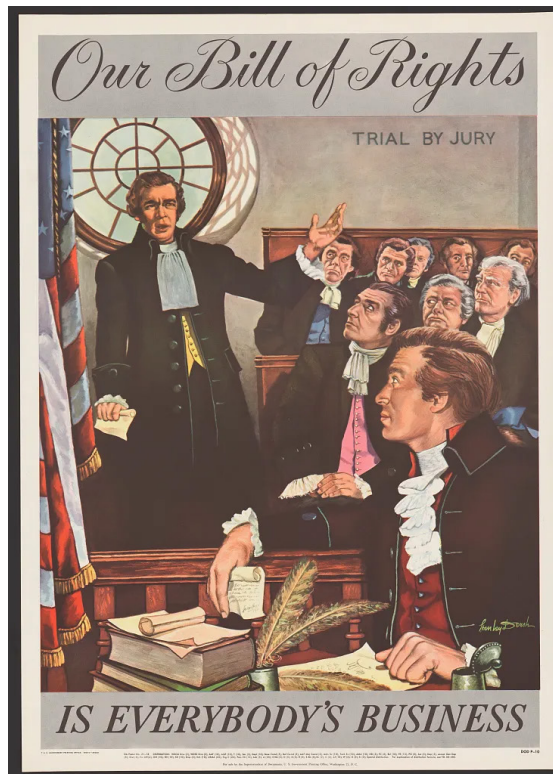

The **Fifth** Amendment to the U.S. Constitution is perhaps best known for its “due process” clause, a clause which is also found in the Fourteenth Amendment. The difference between the two amendments is basically that the Fifth Amendment applies to the federal government and the Fourteenth applies to the states (I will delve into the differences between the two clauses and the significant importance of the Fourteenth Amendment in a future article). According to the 18th Century British jurist Sir William Blackstone, due process means, “The formal commencement of any legal action; the mandate, summons, or writ by which a person or thing is brought into court for litigation.”

Today we might think of due process more broadly, for example, a draft notice during war time and the “due process” by which a prospective warrior is inducted into the military after being vetted to determine fitness for service. Or, when thinking of due process of law, one might think of the process by which one is formally charged with a crime and the ensuing court case. Due process also refers to being subpoenaed to testify in a civil or criminal trial, to having an arrest warrant issued, or even the receipt of a jury summons. The Constitution specifically mentions that only by due process of law is the government able to deprive a citizen of “life, liberty, or property”. The Fifth Amendment places the onus on the government to prove a defendant guilty of a crime and guarantees that the defendant does not have to testify against himself in court (thus a defendant “claims the Fifth Amendment” right not to incriminate oneself) and he cannot be tried twice for the same crime, that is to say, no double jeopardy.

The Fifth Amendment further guarantees that “private property” shall not “be taken for public use without just compensation,” thus the

doctrine of eminent domain. (eminent domain is the ability of the government to seize private property, even if the owner does not want to sell the property). The Fifth Amendment’s limitation on the government’s ability to confiscate private property is limited to public use; to do otherwise is considered an illegal “takings under the Fifth Amendment” unless “just compensation” is given. (Certainly “just compensation” is open to interpretation.) Note: there are some cases in which government regulations are so pervasive that the owner of the property in question entirely loses the ability to benefit from the use of their property; the loss of use is considered a “takings” under the Fifth Amendment.



The **Sixth** Amendment guarantees those charged with a crime of a “speedy and public trial by an impartial jury”. Speedy trials are not the norm these days, as the legal dockets are overflowing, and the courts system is slow. But even the most insignificant trials are open to the public. Why? This is a question I asked my students every semester and without missing a beat they instinctively understood that the legitimacy of a fair trial is only possible when the procedure is open to public scrutiny. The accused is also guaranteed to be told the “nature and cause of the accusation” and to be “confronted with the witnesses against him”. This last point is one that has lately become controversial, as in cases in which a child has been harmed or witnessed a crime, facing the accused may be traumatic. Imagine a child being forced to face the perpetrator in a sexual abuse case, for example.

Under the Sixth Amendment, the defendant in criminal cases is granted the right to compel witnesses for his or her defense to testify before the court. Those compelled to testify are subpoenaed (thus their due process) and under court order must comply and failure to do so can result in legal action. Although the defendant is

guaranteed “the assistance of counsel for his defence” [sic] under the Sixth Amendment, it wasn’t until the Supreme Court case, *Gideon v. Wainwright* (1963) that the right to counsel for indigent in some states was guaranteed. To this day the notion that those who live in poverty are not actually accorded equal access to competent legal defense is a matter of ongoing debate.

Meet the Board: Shellie Okon, Recording Secretary

Shellie Okon was elected Recording Secretary for our Club last year at the November meeting. A Genius in France

Of all the outrages that US citizens had to endure since 2020, the scariest for me personally was the government-sponsored censorship. After Elon bought Twitter, the curtains were drawn back and the light of free speech started pouring in. Independent content creators suddenly had their launch platform restored to them, and that helped turn the 2024 election for President Trump. Since he took office, we have seen DOGE dismantling CISA and all the odious government censorship agencies. Even Facebook and YouTube have loosened up a bit. The mainstream media has a favorability rating lower than whale poop, lower even than Congress.



So yay! Let's take exactly one minute to enjoy that....
Ok. Are you good?

Now let's emblazon on our brains this important fact: all the censorship will come roaring back if we do not work to keep Republicans—MAGA Republicans—in office. For proof, we have only to gaze across the pond at Europe.

In February Vice President JD Vance took European leaders at the Munich Security Conference to task for their censorship of religious and political speech. And rightly so: US media platforms like X are restricted and fined into compliance with EU state censorship, and countries like Britain, Germany, and France have taken their own citizens to court for online speech and for peacefully expressing their opinions in public.

With things so locked down, how do people in Europe express their political views? The ballot box is one place. But alas, the EU and globalist powers have found ways to thwart the will of the people in several national elections. In France, Marine Le Pen is the leader of the so-called "far right" National Rally, which has similarities with MAGA. After winning the national election this past summer she was blocked from participation in the coalition government. Then, on March 31 of this year, in a mirror of the lawfare suffered by Trump, a French court with a judge hand-picked by Macron took her out of contention for the presidency in the 2027 election. Dr. Robert Malone wrote about this injustice in his [SubStack](#).

"She was convicted of embezzlement and barred from running for public office for five years, sentenced to four years in prison, with two years suspended and two under house arrest, and was fined €100,000 (\$108,000)." As with the New York case against Trump, the case was a decades-old finance violation, something that should never have come to court, much less resulted in fines, imprisonment, and disqualification from running for office.

Last fall, Macron and other EU globalists had enough influence to get another court, this time the Supreme Court of Romania, to disqualify the election of populist presidential candidate Călin Georgescu.

In Germany, Merz's government seems to be aiming for an outright ban on the populist AfD party (Alternatives for Germany).

If social media platforms and elections are thwarted, where else can European citizens go to express their opinions, or at least vent their spleen? There is still one rather old-fashioned forum remaining to them: the comments section of online newspapers. Perhaps because some online newspapers still restrict comments to paid subscribers, their editors are a little more open to diversity of opinion than tech platform monitors. Also, the government watchdogs may rightly suppose that the comments won't be seen by many people, and don't bother to censor: no chance for a politically incorrect comment to "go viral".

When you understand their very limited reach, you feel a mixture of pity and admiration for the comment writers; they know that they are writing for a sand box rather than the arena, but nonetheless they put a lot of seriousness, humor, and sometimes ferocity into their efforts. Which oftentimes makes them more engaging than the professionally written articles to which they are appended. People have a deep need to be heard, even though it be in the comments section of a ho-hum online newspaper.

One of my favorite rags of this description is *Le Figaro* of France. How to characterize it? It is not leftist; the Left is very well represented in France and has its own newspapers. The National Rally has its outlets as well. The only thing in the US I can liken it to is *The Wall Street Journal*: somewhat conservative but featuring the globalist elite's interests for the most part. But *Le Figaro* takes comments from all sides—right, left, elite, populist—and they are *très amusant*. I will offer a few samples below.

When Trump threatened in mid-March to put tariffs on their wine and spirits, he hit a sensitive nerve with the French:

*"We'll keep our champagne and he can keep his burgers and Coke."
"American wine lovers will have to fall back on their soft drinks. Mmm, the way this soda lingers on the tongue, the subtle touch of Aspartame—this special vintage is a real baby Jesus in velvet pants!"*

Other commenters were less sarcastic and more Trump-friendly: "Donald Trump is killing three birds with one stone: he is increasing his revenues, protecting his producers, and allowing his people to drink less rot gut, which in the end will be good for their health. Well played, le Donald."

After Trump put the Europeans on notice about needing to pay for their own defense, Macron took to the media spotlight to rally Europe to war against Russia. He appeared in photo ops with troops and the French-made Rafale fighter jets, promising updated models equipped with nukes, "no matter the cost." *Le Figaro* published an [approving article](#)—no doubt this had something to do with *Le Figaro*'s owners being major shareholders in Dassault, the maker of the Rafale.

But *Le Figaro* readers were quick to see through this empty, self-promoting nonsense.

"No matter the cost? He means no matter the cost to us."

"After spending 10 years destroying the French army, this little boy President has a sudden desire to play soldier?" "The environmental wackos will insist on the fighters being electric." Above all, commenters were keenly aware that at the same time Macron was promising to save Europe from Putin, he could not even get France's former colony Algeria to take back some of its nationals who were in France illegally and committing crimes.

"Meanwhile, France is being humiliated by Algeria. Easier to play the strongman against a Russia that is not even threatening us."

When Trump doubled down on his trade war with China, *Le Figaro* published an article entitled "If the trade war keeps going, Americans will consume less, and China will be in crisis." Readers pushed back against that notion.

"Americans will consume less? That's a joke. Drill, baby, drill." "Well, it took some time for the mainstream media to understand Trump's strategy."

*"China will be in crisis? Maybe that would not be such a bad thing."
"China delenda est!"*

"Chinese exports do not depend entirely on the US as the article suggests. China sells to the entire world and will always find places to market its goods."

(That last bit of wisdom must give us all pause.)

Finally, when Trump reached a turning point in his trade war and announced on Truth Social that it was time to buy stocks again, people here in the US and around the world went nuts. The French were no exception. While most commenters were screaming "insider trading", others, more rational, were pointing out that the "insiders" numbered in the billions since Trump had told the entire planet via Truth Social hours before he suspended tariffs that it was time to buy.

"Merci, Mr. Trump. I made a tidy bundle in just a few hours by listening to you. I've already sold off everything and taken my profits."

Another said, *"Exactly. People don't understand Trump. Moi, I understand him very well. I bought."*

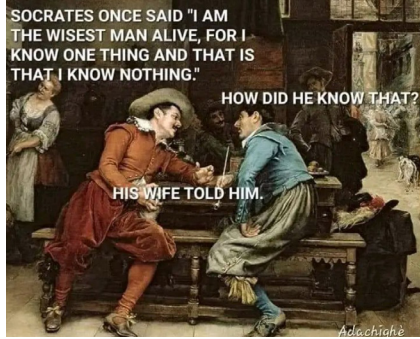
If you have followed me this far you might remember my title for this piece, **A Genius in France**. I was referencing the [Weird Al Yankovic song](#) by that name.

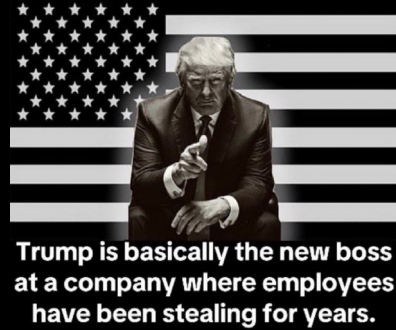

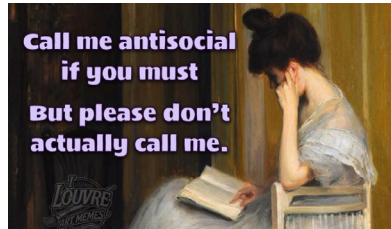
