#### President's Message

"Common Sense Leadership...Our Silver Lining"

The Inauguration of President Trump culminated the voter's mandate that change in this country was necessary. The President immediately took action and went on to sign executive orders and began his journey of getting this country back on track as he promised during the campaign. This man is the "silver lining" in the cloud that has hung over us for the past 4 years.

His series of visits to California, North Carolina, and Nevada were to assess the damage from recent natural disasters and discuss the necessity for effective, common-sense leadership in disaster management. These visits underscored his administration's focus on reforming federal disaster response, which has been seriously lacking and advocating for state-level leadership changes, particularly in California.

Surveying the aftermath of Hurricane Helene, he criticized the Federal Emergency Management Agency (FEMA) for its perceived inefficiency and proposed significant reforms, including the possibility of dismantling the agency. Trump suggested that disaster management responsibilities could be more effectively handled at the state level, thereby reducing federal bureaucracy and expediting recovery efforts.

President Trump then traveled to Los Angeles to assess the destruction caused by recent wildfires. He described the scene as resembling a city "hit by a bomb" and pledged federal support for recovery efforts. Trump reiterated his criticism of California's forest management policies and water resource handling, suggesting that leadership changes were necessary to implement more effective and "common sense" strategies to prevent future disasters. His discussion with Mayor Bass was a classic exchange that left her speechless.

Our president seems to have unlimited energy as he then visited Las Vegas, to discuss his proposal to eliminate federal taxes on tips, a policy aimed at benefiting workers in the hospitality industry. This initiative was part of his broader economic agenda to reduce federal intervention and promote state-level decision-making.

The visit highlighted Trump's overarching theme of advocating for leadership that prioritizes practical solutions and <a href="mailto:empowers local-governance">empowers local-governance</a>. He is a president truly looking out for the people!

As we are aware, local control in California has been taken from us by Governor Newsome and the Democratic supermajority leadership in Sacramento. It's time for the people to take back control of their communities. We must take the time to be better informed and fully understand the issues facing us.

We, the people, must be part of the solution and not allow government overreach control us. Don't let a few make the decisions that will negatively alter our way of life for future generations. Ignorance and apathy are the weapons of those who wish to conquer you.

Throughout these visits, President Trump emphasized the need for "common sense" leadership. He argued that state governments should take a more active role in managing disasters within their jurisdictions, with the federal government providing support rather than direct oversight. In California, Trump specifically called for leadership changes to address what he perceives as systemic issues in forest management and water policies, which he believes have exacerbated the severity of wildfires.

A common view today is that state and local governance in California is a toxic brew of ineffective leadership, misplaced priorities and wishful thinking. A bitter mélange of laws and regulations has distorted the allocation of resources, markets and services. Water infrastructure has been mismanaged, property insurance is hard to come by, and energy costs are high. Blackouts have grown common. While Los Angeles was burning, the state Legislature met to budget a \$50 million slush fund for resistance to the Trump administration.

But the leadership must come from Californians. So far, that appears as likely as a sustainable flow of water from a Pacific Palisades fire hydrant.

#### **Article IV - VII of the Constitution: Lesson VI**

Articles IV, V, VI and VII of the U.S. Constitution complete the document as originally written in 1787. The 1st through 27th Amendments were added later beginning with first ten amendments, the Bill of Rights, written in 1791. Why the gap? I will explain next month.

Article IV of the Constitution addresses relations among the states. This was a topic of great concern for the Framers and their constituents, as the people did not yet think of themselves (today we might say they didn't identify) so much as Americans as they did, say, as Virginians, Georgians or New Yorkers. Recall the preamble to the document notes that the constitution was necessary "...in order to form a more perfect Union..." [Italics added]. Had you been a Frenchman meeting someone from America at the time, asking of your homeland, you may have answered that you were a Pennsylvanian, for example, not that you were an American. Each state had evolved politically and socially for close to, or over 100 years at that point and the people of each state were hesitant to relinquish their sovereignty to an overarching form of government.

Today we think of "state's rights," which is the notion that states should have a reasonable level of autonomy from the federal government in managing their own local affairs. Clearly there would be friction and power struggles between states, regarding trade, legal jurisdiction, tariffs, slavery, military establishment, etc., thus the need for Article IV. (In fact, the Federalist Papers, you may recall, were written for the purpose of persuading the states to ratify the Constitution.)

Under the "Privileges and Immunities" clause, Article IV establishes that the "public acts, records and judicial proceedings" of a given state will be honored by each state. For example, if a couple married in New York and moved to Massachusetts, their marriage is legally held as valid by Massachusetts as it was in New York. The same would hold true regarding contracts between corporations and between citizens of one state contracting with citizens of another state.

Article IV further establishes that new states may be admitted to the Union by Congress, but states are prohibited from joining two or more states to become one and from a portion of a state becoming a state without permission of the state itself and of congress.

And here is a controversial addition to Article IV that is being debated to this day: "The United States shall guarantee to every State in the Union a Republican Form of Government..." To date, there are 26 states that have adopted the initiative and referendum process, which are best described as "direct democracy," and are not therefore, strictly speaking, a republican (representative) form of government; the federal government has stayed out of the debate altogether.

**Article V** explains the process by which the U.S. Constitution may be amended. Although there is more than one process, here is the most employed method and a formula that is easy to understand: Amending the Constitution takes <sup>2</sup>/<sub>3</sub> of the House, <sup>2</sup>/<sub>3</sub> of the Senate and <sup>3</sup>/<sub>4</sub> of the states. (The state legislatures in each state make the decision.)

Amendment =  $\frac{2}{3}$  of the House +  $\frac{2}{3}$  of the U.S. Senate +  $\frac{3}{4}$  of the states.

**Article VI** includes the supremacy clause, which establishes the U.S. Constitution as the supreme law of the land, binds the legal decisions of state judges to the document, "any thing in the Constitution or Laws of any state to the contrary notwithstanding." Article VI also binds state legislatures and governors be held to an oath or affirmation supporting the Constitution and forbids a religious test as a requirement for holding public office.

**Article VII** establishes that nine of the thirteen states must ratify the Constitution; only Rhode Island took its sweet time and didn't ratify until May 29, 1970.




