# California's Has a Debt Addiction

Beware of the propositions on the November ballot. The many bond proposals, both local and state-wide, show that legislators can't kick the debt addiction. For example, two bond proposals of \$10 billion each must be looked at very carefully. The marketing tactics to get you, the voter, to approve these egregious propositions will undoubtedly push all of the emotional buttons.

The biggest threat to California property owners is <u>Proposition 5</u> which, if approved, would lower the vote threshold for bond measures to be passed from two-thirds (66 2/3%) to 55%. Going forward to all future elections, if this proposition is passed, it will open the floodgates to higher property taxes.

More about the propositions will be discussed at our October 16 luncheon meeting at Marbella. 
# The Importance of the United States Constitution: Lesson III

Welcome back to our study of the United States Constitution! Having read Federalist 10 and 51, you have a better understanding of the Founder's approach to forming "a more perfect union." Having been classically trained in the use of logic and reason, the authors of the U.S. Constitution were aware that their constituents did not give them permission to establish an overarching form of government (to which they would be obligated to pay taxes); their task was to revamp the Articles of Confederation. The delegates deliberated for weeks that summer of 1787 and ultimately drafted 7 Articles, establishing a democratic republic. However, the delegates from the 13 states

understood that historically, republics had failed. Why? As James Madison notes in Federalist 10, the failure of representative government could be blamed on *factions* (the F-word of this professor's American Government classes!). Were the Framers throwing caution to the wind and asking the states to adopt a union that was doomed to failure?

The answer is: not exactly; Madison defined a faction as "...a number of citizens, whether amounting to a majority or minority of the whole, who are united and actuated by some common impulse of passion (emphasis mine), or of interest, adverse to the permanent and aggregate interests of the community." Keep in mind that there were no political parties as we know them yet, although political parties (the epitome of a faction to the Founders) began to form soon thereafter. Today we might think of factions more along the lines of interest groups. Factions, Federalist 10 argues, were a result of citizens holding various interests, based on the variety of their "various and unequal" talents, property ownership, opinions, acquisitiveness and their social class.



All these factors, argued Madison, are "sown in the nature of man." Human nature, the immutable factor that divides "mankind into parties," and tends to "inflame them" with mutual animosity and "excites their most violent conflicts," is the culprit.\* And yet, the three authors of the Federalist Papers are arguing that the new republic they are proposing structures the national government (we now call it the federal government) in such a way that human nature has been taken into consideration. Instead of fighting our nature, the Constitution channels our divisive ambitions into a framework of checks and balances on power. Indeed, the purpose of a Constitution is to limit the power of government so that the power remains in the hands of the people and only those powers to which the people *consent* is granted. Madison notes in Federalist 51 that the new national government is designed in such a way that "ambition is made to counteract ambition." I will be referring to the Federalist Papers over and over as we review the Constitution in its entirety.

**Article 1** establishes the legislative branch. Federalist 51 explains that in a republic, "the legislative authority necessarily predominates." As a

\*An aside – while the genius of the Founding generation was their Biblicallybased understanding that man is not perfectible, today's progressives adhere to the views of Jean-Jacques Rousseau (1712 – 1778). Rousseau held that



humans were perfectible; all that was necessary for mankind to improve was to improve his institutions, which were responsible for his failings to begin with (think systemic racism). Personal responsibility cannot be blamed when humans are living within a counter measure to the formidable power of legislating, Article 1 of the new Constitution divides the political power between the people and the states, dividing the legislature into two chambers with one chamber representing the states, the Senate, and one chamber representing the people, the House of Representatives. (The Constitution applied only to the national government and not to state governments until the 14<sup>th</sup> Amendment was ratified following the Civil War). Keep in mind the Framer's classic education was strong on logic and they were keen on ordering topics by order of importance. The Framers clearly intended for the Congress to hold sole responsibility making laws.

**Sections 1 through 6 of Article 1** list the guidelines for electing the two chambers, etc. **Section 7** asserts in the first sentence that *only* the House of Representatives has the power to draft laws for raising revenue. The Senate may merely propose revenue requests or agree with the House on a revenue request. Indeed, the House holds the

"power of the purse"!

Section 8 enumerates the powers that the people consent to allot to congress; to name but a few - the power to tax, the power to borrow money, the power to regulate trade, the power to determine the rules for becoming a citizen, and so on (read it). with one power commonly but erroneously attributed to the president - the power to declare war. The final sentence of Section 8 establishes what is known as "the necessary and proper clause," and is often referred to as the "elastic clause." Think of Queen Latifa trying to get into a pair of Victoria's Secret panties and that's how much the congress stretches this clause, which was added to allow for powers considered necessary to manage a government.

Sections 9 and 10 is an easy read, so I won't go into detail here, but Section 9 begins the process of terminating the slave trade and fills the holes that the Articles of Confederation left open. For example, shoring up habeas corpus, abolishing expost facto laws (laws passed and enforced after an act has taken place), ending the ability of one state to add tariffs to goods that cross state lines and making it clear that


the United States would not establish an aristocracy, therefore denying its citizens titles of nobility. Section 10 limits the state's interference in the national government's overarching powers, such as raising an army.

**But what about the** *factions* that Madison was so leery of? How was the risk to the new republic mitigated? Madison's argument is known as "the enlarged republic" argument and is one that those of us who tend to be partisan particularly ought to keep in mind. Madison noted that most republics had been small, however, with "the extended republic of the United States, and among the variety of interests, parties, and sects, which it embraces, a coalition of a majority of the whole of society could seldom take place upon any other principles than those of justice and the general good…" (Federalist 51). In other words, the more we are divided, the less we are of all of one mind, and are forced to deliberate and wrestle over our differences, the result will be "a judicious modification" of any single point of view and we will remain capable of self-government. Not what you wanted to hear?

flawed system. Sound familiar? Therefore, tearing down a society's institutions and replacing them with progressive institutions becomes not just a political agenda, but a pseudo religious endeavor that justifies canceling those who disagree. Rousseau's views are echoed by two of his countrymen whose ideas are taught in virtually every university in America – Michel Foucault (1926 – 1984), who taught at UC Berkely in the 1970s and Jacques Derrida (1930 – 2004), who taught at Johns Hopkins, NYU and UC Berkeley. Look them up.
