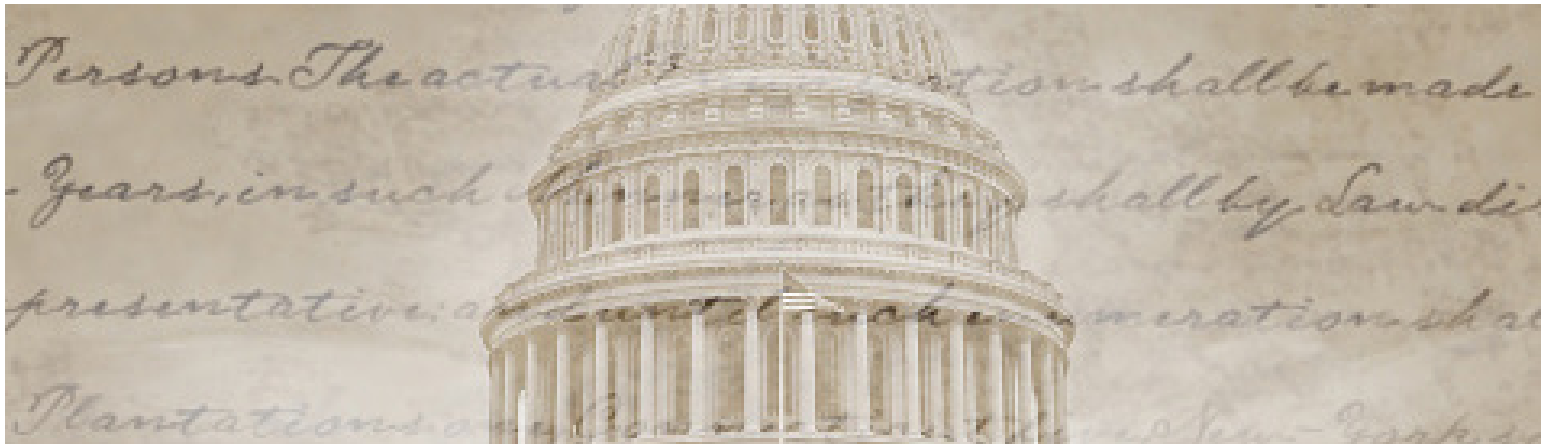


### **Is Donald Trump going to end Daylight Savings Time in 2025?**

## **The Bill of Rights – The First Amendment to the U.S. Constitution: Lesson VII**

Today we think of the Bill of Rights as something sacred, but many of the constitutional Framers thought otherwise. Among those skeptical of a bill of rights was James Madison, the primary author of the U.S. Constitution, including the first ten amendments to the Constitution, known as the Bill of Rights. Recall that the constitution was completed in 1787, but the first ten amendments were not added until 1791. The arguments against adding a bill of rights included that the states already had their own bill of rights, that the constitution itself limited the power of the national government, and a bill of rights was therefore unnecessary, and perhaps most persuasive (and prescient), Alexander Hamilton's argument that defining specific rights would invite overly broad interpretation of the enumerated rights. It should be noted that earlier in this series, we discussed the notion of natural rights, which are rights that are inherent and unalienable. The Framers viewed a bill of rights *not as the government granting its citizens' rights, but as the guarantor of its citizens' rights.*

James Madison had argued in Federalist 10 that an enlarged republic, with a citizenry that held a variety of perspectives, would make a tyranny of the majority or of the minority unlikely and thus a bill of rights unnecessary. He finally relented and supported a bill of rights as a campaign promise he made while running against James Monroe for a coveted seat in the House of Representatives. Once elected, Madison kept his campaign promise and delivered a speech on the House floor in 1789, supporting adding a bill of rights to the U.S. Constitution. Two years later, eleven states ratified the Bill of Rights, putting them into play, with Virginia being the last to ratify in December of 1791. (Keep in mind that, at this time, the U.S. Constitution did not apply to the states.)

The First Amendment is first because the Framers were educated in formal logic and put the most important claim of rights first. **The First Amendment guarantees six freedoms:**

**First**, that "Congress shall make no law" establishing a particular religion.

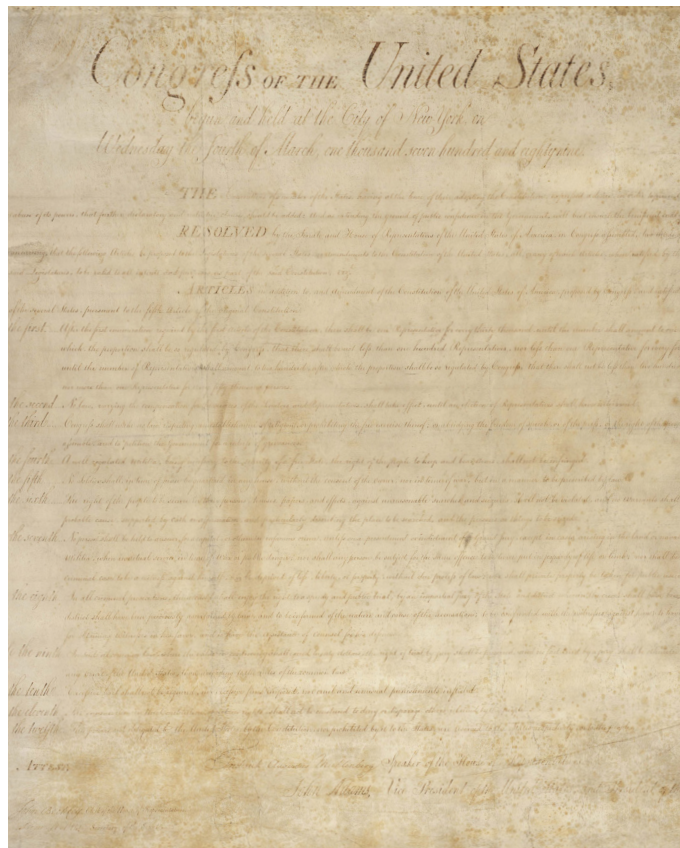
**Second**, nor shall Congress pass any law "prohibiting the free exercise" of any religion, or the lack thereof. Not requiring religious exercise is a guarantee that my own father, an agnostic, took seriously. Often when I taught the First Amendment to undergrads, they would challenge this portion of the First Amendment, wondering whether satanic worship was covered by this guarantee. It is. I would tell them that they could worship the Sun or the Moon if they so chose to do so and their freedom to do so was covered under the First Amendment.

**Third**, Congress shall make no law "abridging freedom of speech." As with any freedom, freedom of speech is not absolute, which was famously pointed out by Supreme Court Justice Oliver Wendell Holmes, Jr. in his 1919 written opinion in *Schenck v. United States*.

**Fourth**, freedom of the press, which was originally meant to protect those who published, including authors of books.

**Fifth**, the right of the people to peacefully assemble. Of course, even a local parade or large gathering requires a permit, but this right was meant to allow Americans to come together and form associations, clubs, guilds, etc. This freedom is one that is quickly removed when tyrannical forces take over a country and is thus of considerable importance.

And **sixth**, the right of the people to petition their government for redress of grievances. Petitioning government for redress includes through lobbying, litigation and seeking policy change through peaceful protest or demonstrations but does not guarantee a particular outcome to the petitioner.



## Election Advocacy Day Article

On February 25, 2025, four members from OCGSRW visited the CA Capital for Election Advocacy Day. They had at least eight appointments set with Assembly and Senate Election Committee Members to discuss the state of our elections. We are also volunteers with United Sovereign Americans (USA), not official spokespersons.

USA is a nationwide organization with thousands of active volunteers in over twenty states. We shared their findings from California's own elections data, obtained via FOIA's (Freedom of Information Act) requests for the **2024 election**. Our objective is Election Validity.

We were very focused in our meetings, sharing the USA data, the how and who obtained the data, and three specific questions for each of our representatives to answer:

- 1) Why are elections certified without regard for their purpose and without proof?
- 2) How can we have certainty without securing every step from registration through certification?
- 3) Will 2026 be too big to rig?

The RISK - USA's analysis shows the voting system is in a Total Loss of Control breach, a national cyber-infrastructure designation defined by the Department of Homeland Security. There is a marauder in our system whose intentions are currently unknown, and there is likely **more than one**.

How do we secure liberty and property for future generations?

To hear my report, please attend the OCGSRW luncheon meeting March 19<sup>th</sup> and I will briefly share during the Americanism portion of the event.

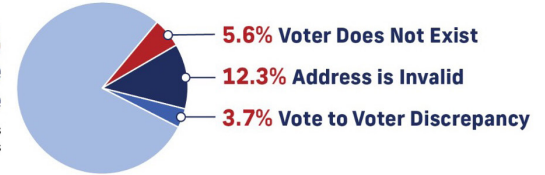

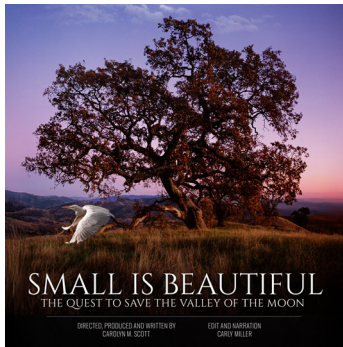

## "Small is Beautiful,"

Carolyn M. Scott's documentary film that focuses on the future of a development project in Northern California's Sonoma County, specifically, the development of the Sonoma County Development Center, ...Something small communities throughout California are facing!!



**SMALL IS BEAUTIFUL** explores the challenges facing a small rural community waging a fierce battle against a massive development project threatening to engulf a wildlife sanctuary and a community's way of life.

Set against the backdrop of California's increasing wildfire risks, the documentary highlights the precarious balance between urban expansion and environmental preservation. This rural community finds itself not only fighting to protect

its natural heritage but also grappling with the potential catastrophic consequences of introducing large-scale development into a fire-prone landscape.

The Sonoma Valley Next 100 Years Project released a proposal in September 2022 that is founded on seven principles: Keep the land at SDC in public ownership in perpetuity; make sure the local community has a strong say in the future of the land; protect the open space and expand the wildlife and riparian corridors; and choose a scale of development that is compatible with the rural character of Sonoma Valley.

"I find the proposal to be profound and comprehensive," Scott said. "It represents a collaborative effort by the community aimed at preserving regional biodiversity while responsibly planning for the future of the land."

In "Small is Beautiful," she explores the challenges facing the rural Sonoma Valley community as it battles urban sprawl and destruction of the wildlife corridor.

"The documentary transitions seamlessly from the local to the statewide perspective, shedding light on new legislations' sweeping impacts across California," she said. "Disguised as 'affordable' housing mandates, these new laws bypass local authority and circumvent environmental and land use regulations."

Scott said that the film raises important questions, such as, "Why are environmental laws circumvented to facilitate luxury housing developments?"

"The film advocates for the principles of decentralization and local empowerment, essential for building resilient communities capable of managing their own lands and resources," she said. "Also, the idea of keeping things small, decentralized and local is central to the idea of building resilient communities that are empowered to manage their own lands and resources, not driven by outside entities that have zero knowledge of the people and lands they live on."

## **Are We Tired of Winning Yet? Heck, No!** **Californians Win Big for MAGA**

As we cheer the wins of the prime movers and shakers in the war against the Deep State—President Trump himself, Elon Musk, and those rollicking 20-somethings at DOGE—let us not forget the less prominent warriors who have fought in the trenches for us the past few years.



First comes to mind our local hero, Dr. Aaron Kheriaty. To refresh your memory, Dr. Kheriaty was the director of the medical ethics program at UC Irvine School of Medicine who was fired for his opposition to vaccine mandates. Together with Dr. Jay Bhattacharya and other prominent experts, he became a plaintiff in the lawsuit now known as *Missouri v. Biden*, which addresses state-sponsored censorship in the digital age.

After he spoke at our luncheon in early 2023, I followed the progress of his lawsuit in the May 2024 and August 2024 editions of this newsletter, [here](#) and [here](#).

The issue at the core of *Missouri v. Biden* could not be more important: freedom of speech, government censorship of media, and equal access to internet platforms. Apparently, President Trump thinks it's important too. On his first day in office he signed an executive order to dismantle the government censorship complex. Dr. Kheriaty gives full details in his January 29, 2025 article in [Substack](#).

The Executive order recognized that “over the last 4 years, the previous administration trampled free speech rights by censoring Americans’ speech on online platforms, often by exerting substantial coercive pressure on third parties, such as social media companies, to moderate, deplatform, or otherwise suppress speech that the Federal Government did not approve.” It ordered the reversal and defunding of this censorship, and directed the Attorney General to begin an investigation of past conduct of those responsible.

Dr. Kheriaty has expressed his delight in this very significant executive order, and he awaits with interest to see what the Attorney General Pam Bondi will turn up in her investigations.

In the meantime, as director of DOGE, Elon Musk has wasted no time acting on this executive order. His brilliant band of 20-somethings has uncovered millions of dollars of payments from USAID and other government agencies to left-wing media outlets like Politico. In a nutshell, our tax dollars have gone to fund propaganda and lies designed to bring down Trump and his MAGA supporters, i.e., you and me, while government-funded censorship has deprived us of access to media platforms where we could defend ourselves.



As for Dr. Kheriaty's free speech case, it was sent back by the Supreme Court last June for lack of standing. However, in August of 2024 it was consolidated with a case brought by Robert F. Kennedy, Jr. and was found to have standing in the second go round. I wrote about this in the [October 2024 newsletter](#).

The consolidated case is known as *Missouri v. Biden*, and we can hope it may soon return to the Court. This issue *needs* to be settled by the Court, and not just by an executive order, however momentous. If not, the censorship we have suffered under these past few years could start up again if the other party returns to power. Nefas nefandi. (*In Latin, that means something like “I don’t even want to think about it.”*)

While we wait to see what happens with *Missouri v. Biden*, we can rejoice in wins for two more California residents: Dr. Jay Bhattacharya and RFK, Jr.



Dr. Bhattacharya of Stanford University is a co-plaintiff in the *Missouri v. Biden* case with RFK, Jr. and Dr. Kheriaty. In late November of 2024 Trump announced he would appoint Dr. Bhattacharya as Director of NIH, the National Institutes of Health: “Together, Jay and RFK, Jr. will restore the NIH to the Gold Standard of Medical Research as they examine the underlying causes of, and solutions to, America’s biggest Health challenges, including our Crisis of Chronic Illness and Disease. Together, they will work hard to Make American Healthy Again!”

In October of 2020 [Dr. Bhattacharya was a respected epidemiologist and professor at the Stanford Medical School](#) when he and Dr. Harvey Risch of Yale and other prominent health professionals signed the Great Barrington Declaration, a critique of the COVID19 lockdowns that were causing untold harm around the world. For his brave effort to turn the course of events, he and his co-signatories were maligned and slandered by Anthony Fauci, Francis Collins, and others in the federal health agencies, and were deplatformed on the internet. In response to this violation of First Amendment rights, he became a co-plaintiff in *Missouri v. Biden*. Now he will oversee the agencies that tried to destroy him and his reputation—the hunted becomes the hunter. We hope that he roots out the corruption there and brings reform.

On February 13 Robert F. Kennedy, Jr., his co-plaintiff in *Missouri v. Biden*, was sworn in as Secretary of Health and Human Services. Talk about the mother of all role-reversals! The man who literally wrote the [book on Fauci](#) is now in charge of Fauci’s former domain? Sweet!

There are so many other wins—too many to count. But not too many to celebrate, as long as the bubbly lasts. I would like to end, though, by spotlighting another Californian, a very local hero, David Daleiden of the Center for Medical Progress in Irvine. I covered his case in the [October 2024 issue of this newsletter](#).

Daleiden is the pro-life activist who at age 24 began work as a citizen journalist to expose violations of federal law by Planned Parenthood. Posing as a potential buyer of aborted fetal remains, Daleiden filmed his

conversations with employees eager to provide the product and published them on the internet in 2015. The damage done to Planned Parenthood's reputation was so great that they sicced Kamala Harris on him.

Then Attorney General of California, Harris probably felt she owed the abortion giant some quid pro quo for its donations to her campaign, so in early 2016 she sent 11 armed agents of the California Department of Justice to his small apartment in Irvine. They seized his equipment and computers, aiming to scrub his videos from the internet. Court rulings blocked further publications of his videos. Harris then proceeded to prosecute Daleiden for violation of California's video recording laws, even though the videos were filmed in public spaces with no expectation of privacy. No other journalist in CA has ever been prosecuted either before or since in this manner. For nine long years Daleiden battled the State of California in court, facing \$25 million in fines and the prospect of spending the rest of his life in prison.

On January 27 of this year, the State of California **dismissed the case** against Daleiden and his fellow undercover reporter Sandra Merritt, and it will be expunged from their records.

Daleiden and his Center for Medical Progress are now free to publish more investigations on their platform. As for Planned Parenthood, CMP's reporting helped disqualify the abortion giant from state and federal funding in Texas, and they **now** face a nearly \$2 billion federal False Claims Act case from the disqualification.

The pro-life heroes that Kamala Harris tried to bury with lawfare have won a complete victory, while one of her big donors is on the run. Stay tuned; we are not tired of winning!

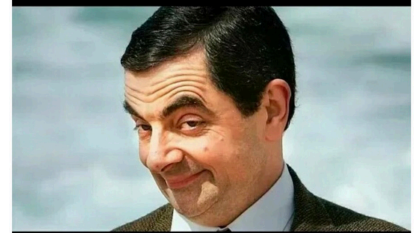
