



## SORRENTO PRIMARY SCHOOL STUDENT UNIFORM POLICY

### **BELIEFS**

A school uniform:

- develops a sense of unity
- fosters a sense among the individual students of being an equal member of the school community
- establishes the identity of the school within the wider community
- ensures practical, safe, clothing for all school activities
- reduces peer pressure and competitiveness over appearance

### **BROAD GUIDELINES**

1. The school uniform colours are red, white and black.
2. The following items of clothing comprise the Sorrento Primary School uniform for all students
  - Red or white long or short sleeved polo shirt.
  - Red and white checked dress.
  - Red short sleeved polar fleece.
  - Red woollen jumper
  - Red windcheater
  - Plain black pants, including plain black shorts, plain black tracksuit pants, plain black leggings and black skorts
  - Black tunic
  - Plain black skirts
  - Optional black beanie (with logo)
  - Plain black or white socks
  - Plain black runners or shoes (no coloured logo)
3. The preferred supplier of the uniform is Beleza in Rosebud.
4. The school logo shall appear on all shirts and jumpers.
5. Plain white skivvy can be worn underneath school tunics.
6. Plain black tights can be worn under tunic/skirt only.
7. Black sport pants (shorts) may be worn underneath summer dress and plain black skirts.
8. Black bike shorts (mid-thigh length- must be seen) can be worn with tops.
9. Bike shorts/hot shorts are not to be worn alone with tops; they can only be worn underneath dresses/tunics.
10. School bag with the school logo is also approved for use (optional)
11. Plain Black Rain/winter jacket may be worn outdoors only (other colours may be worn to and from school)
12. Students can choose their own bathers; rash vests must be worn with bikinis.
13. Uniform that has a school logo will continue to be acceptable, even when phased out
14. Earrings are limited to studs or sleepers in the ear for safety reasons.
15. Students may only wear clear nail polish.
16. Shoulder length hair needs to be tied back with plain brown, black or red hair ties
17. Thongs, high heels and open toed sandals are not permitted.
18. Appropriate black only shoes, boots, runners or closed-toe sandals can be worn (no coloured sole or logo).
19. Hats are a part of the uniform in accordance with the school's Sunsmart Policy. A red wide brimmed hat displaying the school logo is required. Hats are available for purchase at the school.

20. No part of the uniform may be embellished – for example, with studs, lace, zips, logos etc –For the avoidance of any doubt, when the word “plain” is used in this policy, it should be read as a reference to an item of uniform without embellishment.
21. Year 6 students will be able to wear approved tops, organised annually by the Year 6 teachers.
22. No ornamental jewellery may be worn – permission for specific items must be gained from the Uniform Subcommittee

## IMPLEMENTATION

1. The wearing of uniform is compulsory.
2. All children are required to follow the Student Uniform Policy, and to wear the school uniform at all times unless they receive an exemption (see below).
3. Students may not be permitted to represent the school, leave the school on excursions, participate in inter-school sport or other elective activities unless wearing the school uniform.
4. The school uniform may only be altered by a School Council motion.
5. Parents shall be informed by the principal of any action taken against students who are out of uniform.
6. Parental support for the **Student Uniform Policy** is an important part of its successful implementation.
7. The uniform costs will be published in the school Information Pack for prospective parents and students.
8. The Beleza shop hours will be published in the newsletter from time to time.
9. Second hand uniform can be purchased from the school during school hours.
10. Parents experiencing financial hardship can contact the school for support.

## EXEMPTIONS

### Grounds for seeking an exemption:

Parents or guardians may apply for an exemption where:

- An aspect of the Policy offends a religious belief held by the student/parents/guardians.
- An aspect of the Policy prevents the student from complying with a requirement of their ethnic or cultural background.
- An aspect of the Policy prevents students with disabilities from being able to attend school or participate in school activities on the same terms as other students.
- The student has a particular health condition that requires a departure from an aspect of the Policy.
- The student or the parent/guardian can demonstrate particular economic hardship that prevents them from complying with the Policy.

### Procedures for seeking an exemption:

Parents or guardians may seek an exemption by writing to the principal, setting out the grounds for the exemption.

### Procedures for granting an exemption

In response to a written request for exemption the principal should make enquiries and seek evidence as to whether the grounds for exemption are valid, and then determine what kind of exemption is appropriate; for example, a modification of the dress requirement may sometimes be sufficient. When considering a request for exemption on the grounds of economic hardship the principal may grant financial or other assistance to the parent(s)/guardian(s) to enable the student to comply with the dress code without stigma or undue embarrassment.
