TERMS OF AGREEMENT:

Parties: This contract, herein known as the Agreement, is executed on the Registration Date shown above, by and between H.K. Lee Academy of TaeKwonDo, its successors, assigns, and those acting under its authority, herein referred to as Academy. The Buyer, whose signature is affixed hereto, is herein referred to as Buyer. The child, whose birthday the Birthday party is intended and whose name is affixed in this Agreement, is herein known as the Birthday Child. Invited attendees are herein referred to as Guests. The parents and guardians of Guests are herein referred to as Parents/Guardians. The Martial Arts Birthday Party at H.K. Lee Academy of TaeKwonDo for the Buyer, Birthday Child, Guests, and Parents/Guardians is herein referred to as Birthday Party. The collective group consisting of the Buyer, Birthday Child, Guests, and Parents/Guardians is herein referred to as All Parties.

Waivers: Buyer understands that each Parent/Guardian of a non-student guest is required to complete a waiver to provide contact information and agree to the terms of the waiver.

Finance: Payment is due on the day of the Birthday Party and will be presented to the bank on the date of receipt. There will be a \$20.00 service fee for any returned checks, or declined debit/credit payments. If payment is not received on or before the due date, a \$20.00 late fee shall be assessed for the first three business days and \$5.00 for each day thereafter. Balance Due shall become immediately due in full if the Account is deemed in default by more than two weeks and may be submitted to a collection agency.

Liability: Buyer hereby acknowledge the strenuous physical exercise involved in the participation of TaeKwonDo instruction and interactive games provided by the Academy and that All Parties participate at their own risk. Buyer hereby consents to hold the Academy, owner, staff, and assigns free of any and all liability, claims, or actions whatsoever, arising from any injuries, accidents, illness, etc., due to Birthday Party attendance. Further, all parties understand that the Academy, owner, staff, and assigns are not responsible for damaged, lost, or stolen articles inside or outside the Academy.

Media: Buyer, irrevocably authorize the Academy to copyright, use, publish for art, advertising, trade, portraits, pictures, video, audio, and/or any other lawful purpose whatsoever, of the Buyer and/or Birthday Child at the Birthday Party. included in whole or in part.

Force Majeure: The Academy is not liable for failure to perform its obligations if such failure is as a result of "Acts of God", including, but not limited to fire, flood, earthquake, storm, hurricane, or other natural disasters, government intervention, embargo, labor dispute, or failure of electricity, water, internet, or telephone service.

Severability: Agreement provisions that are or become illegal, invalid, or unenforceable shall not affect the validity or enforceability of other Agreement provisions.

Buyers' Rights: Buyer may cancel if Birthday Child is unable to receive benefits from Academy for reasons of the Birthday Child's death or permanent disability that precludes attending the Birthday Party.

Emergency Release: I, the undersigned Buyer, hereby consent to allow the Academy to take such actions as it deems necessary to contact, provide emergency, medical assistance, and transport for the afore specified the Birthday Child.

Gratuity: At least \$20 gratuity is required for each instructor (not included in the total Birthday Fee)

I, the Buyer, acknowledge that I have read (or have had read to me) and fully understand the terms of this Agreement in its entirety.
