Liability: I, the undersigned Buyer, hereby acknowledge that I am aware of the strenuous physical exercise involved in the participation of the Children's Martial Art Summer Camp given by the Center. I hereby consent to hold the Center free of any and all liability, claims, or actions whatsoever, arising from any injuries, accidents, illness, etc., due to the attendance at the Center.

Emergency Release: I, the undersigned Buyer, hereby consent to allow the Center to take such actions as it deems necessary to contact and provide emergency and medical assistance for the afore specified Student(s).

Media Use: I, the undersigned Buyer, irrevocably authorize the Center, its successors, assigns and those acting under its authority, to copyright, use, publish for art, advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures, or video in which the Student(s) or Buyer(s) may be included in whole or in part.

Assessed Fees: I, the undersigned Buyer, hereby acknowledge and agree to the following financial remedies:

1. A \$20.00 fee will be assessed for any check returned or EFT declined.
2. A \$5.00 fee per Student, listed above, will be assessed for every 15 minutes past the 6:30 pm pick-up time.
3. A \$20.00 fee will be assessed for the first three business days, \$5.00 each day thereafter, when tuition is not received the Friday before each subscribed camp week.

Cancellation/Modification Policy: I, the undersigned Buyer, acknowledge the terms of cancellation and modification (moving):

1. Any payment received by the Academy will not be returned to the student or buyer for any reason.
2. At least 1 month (before camp starts or 2 weeks after camp starts) written notice is required to cancel/modify one or more camp weeks.
3. An additional \$50 will be charged to cancel one or more camp weeks.
4. The weekly new rate will be based on the current rate for the sum total of all attended and remaining/added unattended camp weeks.
5. Camp weeks that you have attended will be back charged at the new rate (if different from the original rate).
6. Any promotional discounts or vouchers will be considered void in the event of cancellation of this contract.
