Bylaws:

Michelle C. discussed amending bylaws, which are currently available on the TSNO Region 19 website, to include the following:

Article XVI TSNO Annual Conference:

\$1000 payment to current president to cover conference fees, lodging, and travel for TSNO Conference.

Early-bird Registration fee for Executive Board Members who want to attend the TSNO conference (President Elect, Ex-Officio, VP, VP Elect, Treasurer, and Secretary).

Bylaws will be updated and will be presented to the General membership so that they may vote on the updated bylaws.

Also, there was discussion about adding an amendment to the bylaws to reflect that the Ex-Officio serves only one term on the Executive Committee with voting rights.

Article VI: Section 8:

Checks received shall be deposited into the TSNO account within 14 days of receipt and have a minimum of 2 signers from the standing Board.
