
ADDENDUM

THIS ADDENDUM TO THE INSTRUMENT RESTRICTIVE COVENANT AGREEMENT SHALL FOREVER BE A PART THEREOF AND SHALL BIND ALL PROPERTY OWNERS OF SPORTSMANS PARADISE.

AN ASSESSMENT IS HEREBY CHANGED TO FIVE (\$ 5.00) DOLLARS PER MONTH PER LOT TO THE OWNER OF ONLY ONE LOT IN SAID SUBDIVISION AND AN ASSESSMENT OF THREE (\$ 3.00) DOLLARS PER MONTH PER LOT FOR EACH LOT THEREAFTER, PAYABLE ANNUALLY ON THE FIRST DAY OF JANUARY OF EACH YEAR BEGINNING JANUARY 1, 1998. THE ASSESSMENT IS PAYABLE TO THE SPORTSMANS PARADISE PROPERTY OWNERS ASSOCIATION AT ITS OFFICE IN HENDERSON COUNTY. SUCH CHARGES AND ASSESSMENTS TO BE SECURED BY AN ASSESSMENT LIEN UPON SAID LOTS IF NOT PAID WITHIN SIXTY (60) DAYS OF DUE DATE. THE ASSESSMENT CHARGE FOR A LOT PURCHASED DURING THE CALANDER YEAR SHALL BE PRORATED FROM THE DATE OF PURCHASE TO THE END OF THE CALENDER YEAR. PAYMENTS MAY BE MADE IN ADVANCE BY THE MONTH, OR QUARTERLY. ADDENDUM APPROVED AT THE GENERAL MEETING OF MEMBERS AUGUST 30,1997.
