FIREARM INSTRUCTION WAIVER AND RELEASE OF LIABILITY

This Waiver and Release of Liability ("Agreement") is entered into by the undersigned participant ("Participant") in connection with participation in firearm-related training activities, including both classroom instruction and shooting range exercises, offered by Valor Defense Depot, LLC. ("Training Organization").

01.) Assumption of Risk:

I, the undersigned Participant, acknowledge and understand that participation in firearms training involves inherent risks, including but not limited to gunshot wounds, hearing loss, burns, lacerations, and in extreme cases, serious injury or death. I understand that these risks may result not only from my own actions, but also from the actions of others, the condition of the premises or equipment, or the training environment. I knowingly and voluntarily assume all such risks, known and unknown, whether arising from the negligence of others or otherwise, and choose to participate in this course with full awareness of these risks.

2. Waiver and Release of Liability:

In consideration of being permitted to participate in this firearm training course, I hereby waive, release, discharge, and hold harmless the Training Organization, its owners, officers, instructors, agents, employees, contractors, volunteers, affiliates, and assigns (*collectively, the "Released Parties"*) from any and all claims, demands, damages, liabilities, injuries, losses, or causes of action, including those for bodily injury, death, or property damage, arising out of or connected in any way with my participation in this training course.

03.) Indemnification:

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, liabilities, costs, expenses, or damages (including attorney's fees) arising out of my participation in the course, whether caused by me or others.

04.) Legal Compliance:

I affirm that I am legally permitted to own, possess, and use firearms under applicable federal, state, and local laws. I understand and agree that I am solely responsible for complying with all firearm-related laws and regulations during and after this training course. If signing up a minor, I certify the minor is not a person prohibited from handling a firearm and has the signer's permission to legally handle and discharge a firearm.

05.) Participant's Need to Understand and Follow Instructions:

I understand that it is essential to follow the oral and written instructions provided to me by instructors/training staff, and I agree to do so. I understand that my failure to read instructions, failure to follow the directions of the shooting instructor, range safety officer, or range master could result in serious injury or death to myself or others and therefore agree to abide by the rules with regards to operation on the range. I also recognize that my own failure to fully understand the rules or instructions provided to me regarding safety and operation of firearms could result in serious injury to myself or others. I agree to advise instructors/training staff as to those aspects of the operation or safety involving the use of firearms which I do not understand, and request clarification before participating in any activity.

06.) Participant's Insurance/Physical Condition:

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume, and bear the costs of, all risks that may be created, directly or indirectly, by any such condition.

07.) Participant Acknowledgement:

- I have read and fully understand this Waiver and Release of Liability.
- I understand that I am giving up substantial legal rights by signing it.
- I am signing this Agreement voluntarily, without coercion or duress.
- I am of legal age and of sound mind to execute this Agreement.
